

Convergence Analysis of General Version of Gauss-Type Proximal Point Method for Metrically Regular Mappings

Abstract

We introduce and study in the present paper the general version of Gauss-type proximal point algorithm (in short GG-PPA) for solving the inclusion $0 \in T(x)$, where T is a set-valued mapping which is not necessarily monotone acting from a Banach space X to a subset of a Banach space Ywith locally closed graph. The convergence of the GG-PPA is present here by choosing a sequence of functions $g_k : X \to Y$ with $g_k(0) = 0$, which is Lipschitz continuous in a neighbourhood O of the origin and when T is metrically regular. More precisely, semi-local and local convergence of GG-PPA are analyzed. Moreover, we present a numerical example to validate the convergence result of GG-PPA.

1. Introduction

We are concerned in this study with the problem of finding a point $x \in \Omega \subseteq X$ satisfying

(

$$0 \in T(x), \tag{1}$$

where $T: X \Longrightarrow 2^{Y}$ is a set-valued mapping and X and Y are Banach spaces. This type of inclusion is an abstract

In particular, it may characterize optimality or equilibrium problems. Choose a sequence of functions $g_k: X \to Y$ with $g_k(0) = 0$ which is Lipschitz continuous in a neighborhood O of the origin.

Martinet [1] proposed the following algorithm for the first time for applying it to convex optimization by considering a sequence of scalars $\{\lambda_k\}$, which are different from zero:

$$0 \in \lambda_k \left(x_{k+1} - x_k \right) + T \left(x_{k+1} \right), \text{ for each } k = 0, 1, 2, \cdots$$
(2)

Rockafellar [2] thoroughly explored the method (2) in the general framework of maximal monotone inclusions. In particular, Rockafellar ([2], Theorem 1) shows that when x_{k+1} is an approximate solution of (2) and T is maximal monotone, then for a sequence of positive scalars λ_k the iteration (2) generates a sequence $\{x_k\}$ which is weakly convergent to a solution of (1) for any starting point $x_0 \in X$. In [3], Aragón Artacho *et al.* have been presented the general version of the proximal point algorithm (GPPA) (see Algorithm 1), for the case of nonmonotone mappings, for solving the inclusion (1).

Let $x \in X$. The subset of X, denoted by $D^k(x)$, is defined by

$$D^{k}(x) := \{ d \in X : 0 \in g_{k}(d) + T(x+d) \}.$$

Thus we have the following algorithms which have been presented by Aragón Artacho et al. [3]:

Algorithm 1 (GPPA) Step 1. Select $x_0 \in X$, $\lambda \in (0, \infty)$ and put k := 0. Step 2. If $0 \in D^k(x_k)$, then stop; otherwise, go to Step 3. Step 3. Put $\{\lambda_k\} \subseteq (0, \lambda)$, $g_k(0) = 0$ and if $0 \notin D^k(x_k)$, choose d_k such that $d_k \in D^k(x_k)$. Step 4. Set $x_{k+1} := x_k + d_k$. Step 5. Replace k by k+1 and go to Step 2.

Note that, for a starting point near to a solution, the sequences generated by **Algorithm 1** are not uniquely defined and not every sequence is convergent. The results obtained in [3] guarantee the existence of one sequence, which is convergent. Therefore, from the viewpoint of numerical computation, we can assume that these kinds of methods are not suitable in practical application. This drawback motivates us to introduce a method "socalled" general version of Gauss-type proximal point algorithm (GG-PPA). The difference between **Algorithm 1** and our proposed **Algorithm 2** is that the GG-PPA generates sequences, whose every sequence is convergent, but this does not happen for **Algorithm 1**. Thus we propose here the GG-PPA as follows:

> Algorithm 2 (GG-PPA) Step 1. Select $\eta \in [1,\infty)$, $x_0 \in X$, $\lambda \in (0,\infty)$ and put k := 0. Step 2. If $0 \in D^k(x_k)$, then stop; otherwise, go to Step 3. Step 3. Put $\{\lambda_k\} \subseteq (0,\lambda)$, $g_k(0) = 0$ and if $0 \notin D^k(x_k)$, choose d_k such that $d_k \in D^k(x_k)$ and $\|d_k\| \leq \eta \operatorname{dist}(0, D^k(x_k))$. Step 4. Set $x_{k+1} := x_k + d_k$. Step 5. Replace k by k+1 and go to Step 2.

We observe, from Algorithm 2, that

1) if $g_k(u) = \lambda_k u$ and then we assume Y = X a Hilbert space, this algorithm reduces to the classical proximal point algorithm defined by (2).

2) if $g_k(u) = \lambda_k u$, Algorithm 2 is equivalent to the classical Gauss-type proximal point method, which has been introduced by Rashid *et al.* [4].

A large number of authors have been studied on proximal point algorithm and have also found applications of this method to specific variational problems. Most of the study on this subject have been concentrated on various versions of the algorithm for solving inclusions involving monotone mappings, and specially, on monotone variational inequalities (see in [5]-[8]). Spingarn [9] has been studied first weaker form of monotonicity and for details see in [10].

There have a large study on local convergence analysis about **Algorithm 1** (cf. [3] [11] [12]), but there is no semilocal analysis for **Algorithm 1**. A huge number of contributions have been studied on semilocal analysis for the Gauss-Newton method (cf. [4] [13]-[16]). In [4], Rashid *et al.* have given a semilocal convergence analysis for the classical Gauss-type proximal point method. As our best knowledge, there is no study on semilocal analysis for **Algorithm 2**. Therefore we conclude that the contributions presented in this study are seems new.

In the present paper, our aim is to study the semilocal convergence for the GG-PPA defined by **Algorithm 2**. The metric regularity property and Lipschitz-like property for set-valued mappings are mainly used in our study. The main results are convergence analysis, established in section 3, which based on the attraction region around the initial point and provide some sufficient conditions ensuring the convergence to a solution of any sequence generated by **Algorithm 2**. As a consequence, local convergence results for GG-PPA are obtained.

This paper is arranged as follows. In Section 2, some necessary notations, notions and preliminary results are presented. In Section 3, we consider the GG-PPA which is introduced in Section 1 and by using the concept of metric regularity property for the set valued mapping T, we will show the existence and present the convergence of the sequence generated by **Algorithm 2**. In Section 4, we present a numerical experiment to validate the semilocal convergence of **Algorithm 2**. In the last Section, we will give a summary of the major results to close our paper.

2. Notations and Preliminary Results

In the whole paper, we assume that X and Y are Banach spaces. Let F be a set-valued mapping from X into the subsets of Y, denoted by $F: X \Rightarrow 2^Y$. Let $x \in X$ and r > 0. The closed ball centered at x with radius r is denoted by $\mathbb{B}_r(x)$. The domain domF, the inverse F^{-1} and the graph gphF of F are respectively defined by

dom
$$F := \{x \in X : F(x) \neq \emptyset\},\$$

 $F^{-1}(y) := \{x \in X : y \in F(x)\}$

and

gph
$$F := \{(x, y) \in X \times Y : y \in F(x)\}$$

All the norms are denoted by $\|\cdot\|$. Let $A \subseteq X$ and $C \subseteq X$. The distance from x to A is defined by

$$dist(x, A) := \inf \{ \|x - a\| : a \in A \} \text{ for each } x \in X,$$

while the excess from the set C to the set A is defined by

$$e(C, A) := \sup \left\{ \operatorname{dist} (x, A) : x \in C \right\}$$

From [4], we recall the following definition of metric regularity for set-valued mapping.

Definition 1 Let $F: X \rightrightarrows Y$ be a set-valued mapping and let $(\overline{x}, \overline{y}) \in \text{gph}F$. Let $r_{\overline{x}} > 0, r_{\overline{y}} > 0$ and $\kappa > 0$. Then F is said to be

1) metrically regular at $(\overline{x}, \overline{y})$ on $\mathbb{B}_{r_{\overline{x}}}(\overline{x}) \times \mathbb{B}_{r_{\overline{x}}}(\overline{y})$ with constant κ if

$$\operatorname{dist}(x, F^{-1}(y)) \leq \kappa \operatorname{dist}(y, F(x)) \quad \text{for all } x \in \mathbb{B}_{r_{\overline{v}}}(\overline{x}), y \in \mathbb{B}_{r_{\overline{v}}}(\overline{y}). \tag{4}$$

2) metrically regular at $(\overline{x}, \overline{y})$ if there exist constants $r'_{\overline{x}} > 0, r'_{\overline{y}} > 0$ and $\kappa > 0$ such that F is metrically regular at $(\overline{x}, \overline{y})$ on $\mathbb{B}'_{r_{\overline{y}}}(\overline{x}) \times \mathbb{B}'_{r_{\overline{y}}}(\overline{y})$ with constant κ .

The infimum of the set of values κ for which (4) holds is the modulus of metric regularity, denoted by

reg $F(\overline{x} | \overline{y})$. The absence of metric regularity at \overline{x} for \overline{y} corresponds to reg $F(\overline{x} | \overline{y}) = \infty$. The inequality (4) has direct use in providing an estimate for how far a point x is from being a solution to the generalized equation $y \in F(x)$ and the expression dist(y, F(x)) measures the residual when $y \in F(x)$.

Recall the definition of Lipschitz-like continuity for set-valued mapping from [17]. This notion was introduced by Aubin in [18] and has been studied extensively.

Definition 2 Let $\Gamma: Y \Longrightarrow 2^X$ be a set-valued mapping and let $(\overline{y}, \overline{x}) \in \text{gph}\Gamma$. Let $r_{\overline{x}} > 0, r_{\overline{y}} > 0$ and M > 0. Then Γ is said to be Lipchitz-like at $(\overline{y}, \overline{x})$ on $\mathbb{B}_{r_{\overline{y}}}(\overline{y}) \times \mathbb{B}_{r_{\overline{x}}}(\overline{x})$ with constant M if the following inequality hold:

$$e\left(\Gamma(y_1) \cap \mathbb{B}_{r_{\overline{x}}}(\overline{x}), \Gamma(y_2)\right) \le M \|y_1 - y_2\| \quad \text{for any } y_1, y_2 \in \mathbb{B}_{r_{\overline{y}}}(\overline{y}).$$

The following result establish the equivalence relation between metric regularity of a mapping F at $(\overline{x}, \overline{y})$ and the Lipschitz-like continuity of the inverse F^{-1} at $(\overline{y}, \overline{x})$, which is obtained from the idea in [19] [20].

Lemma 1 Let $F: X \rightrightarrows 2^{Y}$ be a set valued mapping and $\overline{y} \in F(\overline{x})$. Let $r_{\overline{x}} > 0, r_{\overline{y}} > 0$, then F is metrically regular at $(\overline{x}, \overline{y})$ on $\mathbb{B}_{r_{\overline{x}}}(\overline{x}) \times \mathbb{B}_{r_{\overline{y}}}(\overline{y})$ if and only if its inverse $F^{-1}: Y \rightrightarrows 2^{X}$ is Lipschitz-like at $(\overline{y}, \overline{x})$ on $\mathbb{B}_{r_{\overline{x}}}(\overline{y}) \times \mathbb{B}_{r_{\overline{y}}}(\overline{y})$ with constant $\kappa > 0$ such that

$$e\left(F^{-1}(y) \cap \mathbb{B}_{r_{\overline{x}}}(\overline{x}), F^{-1}(y')\right) \leq \kappa \|y - y'\| \text{ for all } y, y' \in \mathbb{B}_{r_{\overline{y}}}(\overline{y}).$$

We recall the following statement of Lyusternik-Graves theorem for metrically regular mapping from [21]. This theorem plays an important role in the theory of metric regularity and proves the stability of metric regularity of a generalized equation under perturbations. For its statement, we use that a set $C \subset X$ is locally closed at $z \in C$ if there exists a > 0 such that the set $C \cap \mathbb{B}_a(z)$ is closed. **Lemma 2** Consider a mapping $F: X \rightrightarrows 2^Y$ and any $(\overline{x}, \overline{y}) \in \operatorname{gph} F$ at which gph F is locally closed.

Lemma 2 Consider a mapping $F: X \Rightarrow 2^{Y}$ and any $(\overline{x}, \overline{y}) \in \operatorname{gph} F$ at which $\operatorname{gph} F$ is locally closed. Let F be metrically regular at \overline{x} for \overline{y} with constant $\kappa > 0$. Consider also a function $g: X \to Y$ which is Lipschitz continuous at \overline{x} with Lipschitz constant λ such that $\lambda < \kappa^{-1}$. Then the mapping g + F is metric-

ally regular at \overline{x} for $\overline{y} + g(\overline{x})$ with constant $\frac{\kappa}{1-\kappa\lambda}$.

We finished this section with the following lemma, which is known as Banach fixed point theorem proved in [22].

Lemma 3 Let $\Phi: X \rightrightarrows 2^X$ be a set-valued mapping. Let $\eta_0 \in X$, $r \in (0,\infty)$ and $\alpha \in (0,1)$ be such that

$$\operatorname{dist}(\eta_0, \Phi(\eta_0)) < r(1 - \alpha) \tag{6}$$

and

$$e(\Phi(x_1) \cap \mathbb{B}_r(\eta_0), \Phi(x_2)) \le \alpha \|x_1 - x_2\| \quad \text{for any } x_1, x_2 \in \mathbb{B}_r(\eta_0).$$

$$\tag{7}$$

Then Φ has a fixed point in $\mathbb{B}_r(\eta_0)$, that is, there exists $x \in \mathbb{B}_r(\eta_0)$ such that $x \in \Phi(x)$. If Φ is additionally single-valued, then the fixed point of Φ in $\mathbb{B}_r(\eta_0)$ is unique.

3. Convergence Analysis of GG-PPA

In this section, we assume that $T: X \Rightarrow 2^Y$ is a set-valued mapping with locally closed graph at $(\overline{x}, \overline{y}) \in \text{gph } T$ such that T is metrically regular at $(\overline{x}, \overline{y})$ with constant $\kappa > 0$. Let $g: X \to Y$ be a (single-valued) function such that g(0) = 0, which is Lipschitz continuous in a neighborhood O of 0 with a Lipschitz constant $\lambda > 0$. Let $x \in X$ and define a mapping P_x by

$$P_{x}(\cdot) \coloneqq g(\cdot - x) + T(\cdot).$$
(8)

Then we obtain the following equivalence

$$z \in P_x^{-1}(y) \Leftrightarrow y \in g(z-x) + T(z) \text{ for any } z \in X \text{ and } y \in Y.$$
(9)

In particular,

$$\overline{x} \in P_{\overline{x}}^{-1}(\overline{y})$$
 for each $(\overline{x}, \overline{y}) \in \operatorname{gph} T$. (10)

Let $(\overline{x}, \overline{y}) \in \text{gph}(g+T)$ and let $r_{\overline{x}} > 0, r_{\overline{y}} > 0$. Since $g(\cdot -\overline{x})$ is Lipschitz continuous on $O + \overline{x}$, applying the Lyusternik-Graves theorem (see Lemma 2) we assume that the mapping $P_{\overline{x}}$ is metrically regular at $(\overline{x}, \overline{y})$ with constant $\frac{\kappa}{1-\kappa\lambda}$, that is, by Lemma 1 we have the following inequality

$$e\left(P_{\overline{x}}^{-1}\left(y\right) \cap \mathbb{B}_{r_{\overline{x}}}\left(\overline{x}\right), P_{\overline{x}}^{-1}\left(y'\right)\right) \leq \frac{\kappa}{1-\kappa\lambda} \|y-y'\| \text{ for all } y, y' \in \mathbb{B}_{r_{\overline{y}}}\left(\overline{y}\right).$$
(11)

Write

$$\overline{r} := \min\left\{\frac{2r_{\overline{y}} - r_{\overline{x}}\lambda}{2}, \frac{r_{\overline{x}}\left(1 - 3\kappa\lambda\right)}{4\kappa}\right\}.$$
(12)

Then

$$\overline{r} > 0 \Leftrightarrow \lambda < \min\left\{\frac{2r_{\overline{y}}}{r_{\overline{x}}}, \frac{1}{3\kappa}\right\}.$$
(13)

The following lemma plays an important role for convergence analysis of the GG-PPA, which is due to [23].

Lemma 4 Suppose that $P_{\overline{x}}(\cdot)$ is metrically regular at $(\overline{x}, \overline{y})$ on $\mathbb{B}_{r_{\overline{x}}}(\overline{x}) \times \mathbb{B}_{r_{\overline{y}}}(\overline{y})$ with constant $\frac{\kappa}{1-\kappa\lambda}$ such that (12) and (13) are satisfied. Let $x \in \mathbb{B}_{\frac{r_{\overline{x}}}{2}}(\overline{x})$ and $\mathbb{B}_{r_{\overline{x}}}(0) \subset O$. Then $P_x^{-1}(\cdot)$ is Lipschitz-like at $(\overline{y}, \overline{x})$ on $\mathbb{B}_{\overline{r}}(\overline{y}) \times \mathbb{B}_{\frac{r_{\overline{x}}}{2}}(\overline{x})$ with constant $\frac{\kappa}{1-3\kappa\lambda}$, that is, $e\left(P_x^{-1}(y_1) \cap \mathbb{B}_{\frac{r_{\overline{x}}}{2}}(\overline{x}), P_x^{-1}(y_2)\right) \leq \frac{\kappa}{1-3\kappa\lambda} \|y_1 - y_2\|$ for any $y_1, y_2 \in \mathbb{B}_{\overline{r}}(\overline{y})$.

For our convenience, we consider a sequence of functions $g_k: X \to Y$ with $g_k(0) = 0$ which are Lipschitz continuous in a neighbourhood O of 0, the same for all k, with Lipschitz constants λ_k satisfying

$$\lambda := \sup_{k} \lambda_k < \frac{1}{6\kappa}.$$
 (14)

We rewrite the mapping $P_x(\cdot)$ in (8) by substituting g_k instead of g as follows:

$$P_x^k\left(\cdot\right) \coloneqq g_k\left(\cdot - x\right) + T\left(\cdot\right) \quad \text{for each } k = 0, 1, 2, \cdots.$$

Since $\lambda \kappa < \frac{1}{6} < 1$ by (14), then by Lyusternik-Graves theorem (see Lemma 2) and Lemma 1 we obtain that the mapping $P_{\overline{x}}^{k-1}(\cdot)$ is Lipschitz-like at $(\overline{y}, \overline{x})$ on $\mathbb{B}_{r_{\overline{y}}}(\overline{y}) \times \mathbb{B}_{r_{\overline{x}}}(\overline{x})$ with constant $\frac{\kappa}{1-\kappa\lambda}$ satisfying (11) and hence we have

$$D^{k}(x) = \left\{ d \in X : 0 \in P_{x}^{k}(x+d) \right\}.$$
 (16)

Furthermore, we define, for each $x \in X$, the mapping $Z_x : X \rightrightarrows Y$ by

$$Z_x^k(\cdot) \coloneqq g_k(\cdot - \overline{x}) - g_k(\cdot - x), \tag{17}$$

and the set-valued mapping $\Phi_x^k: X \Longrightarrow 2^X$ by

$$\Phi_x^k(\cdot) \coloneqq P_{\overline{x}}^{k-1} \Big[Z_x^k(\cdot) \Big].$$
(18)

Then

$$\begin{aligned} \left\| Z_{x}^{k} \left(x' \right) - Z_{x}^{k} \left(x'' \right) \right\| \\ &= \left\| g_{k} \left(x' - \overline{x} \right) - g_{k} \left(x' - x \right) - g_{k} \left(x'' - \overline{x} \right) + g_{k} \left(x'' - x \right) \right\| \\ &\le \left\| g_{k} \left(x' - \overline{x} \right) - g_{k} \left(x'' - \overline{x} \right) \right\| + \left\| g_{k} \left(x' - x \right) - g_{k} \left(x'' - x \right) \right\| \text{ for each } x', x'' \in X. \end{aligned}$$

$$(19)$$

The main result of this study given as follows, which provides some sufficient conditions ensuring the convergence of the GG-PPA with initial point x_0 .

Theorem 1 Suppose $\eta > 1$ and that $P_{\overline{x}}^k(\cdot)$ is metrically regular at $(\overline{x}, \overline{y})$ on $\mathbb{B}_{r_{\overline{y}}}(\overline{x}) \times \mathbb{B}_{r_{\overline{y}}}(\overline{y})$ with

constant
$$\frac{\kappa}{1-\kappa\lambda}$$
, and let \overline{r} be defined in (12). Let $\mathbb{B}_{r_{\overline{x}}}(\overline{x}) \subset O$ and $\delta > 0$ be such that
a) $\delta \leq \min\left\{\frac{r_{\overline{x}}}{4}, \frac{\overline{r}}{2\lambda}, \frac{r_{\overline{y}}}{3\lambda}, 1, \frac{1-\lambda\kappa}{6\kappa\lambda}\right\}$,
b) $(\eta+3)\kappa\lambda \leq 1$,
c) $\|\overline{y}\| < \lambda\delta$.
Suppose that

$$\lim_{x \to \overline{x}} \operatorname{dist}\left(\overline{y}, T\left(x\right)\right) = 0.$$
(20)

Then there exists some $\hat{\delta} > 0$ such that any sequence $\{x_k\}$ generated by **Algorithm 2** with initial point in $\mathbb{B}_{\hat{\delta}}(\bar{x})$ converges to a solution x^* of (1), that is, x^* satisfies that $0 \in T(x^*)$. *Proof.* Let

$$t := \frac{\eta \kappa \lambda}{1 - 3\kappa \lambda}.$$
(21)

Then by assumption (b), (21) gives us

 $t \le 1. \tag{22}$

Assumption (c) and (20) allow us to take $0 < \hat{\delta} \le \delta$ so that

dist
$$(0, T(x_0)) \le \lambda \delta$$
 for each $x_0 \in \mathbb{B}_{\hat{s}}(\overline{x})$. (23)

We will proceed by mathematical induction and show that Algorithm 2 generates at least one sequence and any sequence $\{x_k\}$ generated by Algorithm 2 satisfies the following assertions

$$\left\|x_{k}-\overline{x}\right\| \leq 2\delta,\tag{24}$$

and

$$\left\|x_{k+1} - x_{k}\right\| \le t^{k+1}\delta \tag{25}$$

for each $k = 0, 1, 2, \cdots$. Define

$$r_{x} \coloneqq \frac{5\kappa}{3(1-\lambda\kappa)} \left(\left\| \overline{y} \right\| + \lambda \left\| x - \overline{x} \right\| \right) \text{ for each } x \in X.$$

$$(26)$$

Since $\eta > 1$, by assumption (b) and (c), we have

$$r_{x} \leq \frac{5\kappa\lambda}{1-\lambda\kappa}\delta \leq \frac{5}{\eta+2}\delta \leq 2\delta \text{ for each } x \in \mathbb{B}_{2\delta}(\overline{x}).$$
(27)

It is trivial that (24) is true for k = 0. For showing that (25) is true for k = 0, we need to prove that x_1 exists, that is, $D^0(x_0) \neq \emptyset$. We will prove $D^0(x_0) \neq \emptyset$ by applying Lemma 3 to the mapping $\Phi_{x_0}^0$ with $\eta = \overline{x}$. Let us check that both assertions (6) and (7) of Lemma 3 are hold with $r := r_{x_0}$ and $\alpha := \frac{2}{5}$. Noting that

 $\overline{x} \in P_{\overline{x}}^{0^{-1}}(\overline{y}) \cap \mathbb{B}_{r_{x_0}}(\overline{x})$ by (10). Then by the mapping $\Phi_{x_0}^0$ in (18) and the definition of excess *e*, we have

$$dist\left(\overline{x}, \Phi_{x_{0}}^{0}\left(\overline{x}\right)\right) \leq e\left(P_{\overline{x}}^{0-1}\left(\overline{y}\right) \cap \mathbb{B}_{r_{x_{0}}}\left(\overline{x}\right), \Phi_{x_{0}}^{0}\left(\overline{x}\right)\right) \leq e\left(P_{\overline{x}}^{0-1}\left(\overline{y}\right) \cap \mathbb{B}_{2\delta}\left(\overline{x}\right), \Phi_{x_{0}}^{0}\left(\overline{x}\right)\right)$$

$$\leq e\left(P_{\overline{x}}^{0-1}\left(\overline{y}\right) \cap \mathbb{B}_{r_{\overline{x}}}\left(\overline{x}\right), P_{\overline{x}}^{0-1}\left[Z_{x_{0}}^{0}\left(\overline{x}\right)\right]\right)$$

$$(28)$$

(noting that $\mathbb{B}_{r_{x_0}}(\overline{x}) \leq \mathbb{B}_{2\delta}(\overline{x}) \subseteq \mathbb{B}_{r_{\overline{x}}}(\overline{x})$). Now, by the choice of λ , we have

$$\begin{aligned} \left\| Z_{x_{0}}^{0}(x) - \overline{y} \right\| &= \left\| g_{0}(x - \overline{x}) - g_{0}(x - x_{0}) - \overline{y} \right\| \leq \left\| g_{0}(x - \overline{x}) - g_{0}(x - x_{0}) \right\| + \left\| \overline{y} \right\| \\ &\leq \lambda_{0} \left\| x_{0} - \overline{x} \right\| + \left\| \overline{y} \right\| \leq \lambda \left\| x_{0} - \overline{x} \right\| + \left\| \overline{y} \right\|. \end{aligned}$$
(29)

Since $x_0 \in \mathbb{B}_{\hat{\delta}}(\overline{x}) \subset \mathbb{B}_{\delta}(\overline{x})$, by the fact $3\lambda \delta \leq r_{\overline{y}}$ in assumption (a) and $\|\overline{y}\| \leq \lambda \delta$ in assumption (c), for each $x \in \mathbb{B}_{\delta}(\overline{x})$, (29) implies that

$$\left\|Z_{x_0}^0\left(x\right) - \overline{y}\right\| \le 2\lambda\delta \le r_{\overline{y}},\tag{30}$$

that is, for each $x \in \mathbb{B}_{\delta}(\overline{x})$, $Z_{x_{0}}^{0}(x) \in \mathbb{B}_{r_{\overline{y}}}(\overline{y})$. In particular,

$$Z_{x_{0}}^{0}\left(\overline{x}\right) - \overline{y} \| = \left\| -g_{0}\left(\overline{x} - x_{0}\right) - \overline{y} \right\| \leq \left\| g_{0}\left(0\right) - g_{0}\left(\overline{x} - x_{0}\right) \right\| + \left\| \overline{y} \right\|$$

$$\leq \lambda_{0} \left\| x_{0} - \overline{x} \right\| + \left\| \overline{y} \right\| \leq \lambda \left\| x_{0} - \overline{x} \right\| + \left\| \overline{y} \right\| \leq 2\lambda\delta \leq r_{\overline{y}}.$$
(31)

Hence by using (31) and Lemma 1 for Lipschitz-like property in (28), we have

$$\operatorname{dist}\left(\overline{x}, \Phi_{x_{0}}^{0}\left(\overline{x}\right)\right) \leq \frac{\kappa}{1-\kappa\lambda} \left\|\overline{y} - Z_{x_{0}}^{0}\left(\overline{x}\right)\right\| \leq \frac{\kappa}{1-\kappa\lambda} \left(\left\|\overline{y}\right\| + \lambda \left\|x_{0} - \overline{x}\right\|\right)$$
$$= \left(1 - \frac{2}{5}\right) r_{x_{0}} = (1 - \alpha) r.$$

This shows that assertion (6) of Lemma 3 is satisfied. Now, we show that the assertion (7) of Lemma 3 is satisfied. Let $x', x'' \in \mathbb{B}_{r_{x_0}}(\overline{x})$. Then by assumption (a) and (27), we have $x', x'' \in \mathbb{B}_{r_{x_0}}(\overline{x}) \subseteq \mathbb{B}_{2\delta}(\overline{x}) \subseteq \mathbb{B}_{r_{\overline{x}}}(\overline{x})$ and $Z_{x_0}^0(x'), Z_{x_0}^0(x'') \in \mathbb{B}_{r_{\overline{y}}}(\overline{y})$ by (30). By assumed Lipschitz-like property of $P_{\overline{x}}^{0^{-1}}(\cdot)$, we have

$$e\left(\Phi_{x_{0}}^{0}(x') \cap \mathbb{B}_{r_{x_{0}}}(\bar{x}), \Phi_{x_{0}}^{0}(x'')\right) \leq e\left(\Phi_{x_{0}}^{0}(x') \cap \mathbb{B}_{r_{\bar{x}}}(\bar{x}), \Phi_{x_{0}}^{0}(x'')\right)$$

$$= e\left(P_{\bar{x}}^{0-1}\left[Z_{x_{0}}^{0}(x')\right] \cap \mathbb{B}_{r_{\bar{x}}}(\bar{x}), P_{\bar{x}}^{0-1}\left[Z_{x_{0}}^{0}(x'')\right]\right)$$

$$\leq \frac{\kappa}{1-\kappa\lambda} \left\|Z_{x_{0}}^{0}(x') - Z_{x_{0}}^{0}(x'')\right\|.$$
(32)

Applying (19) in (32), we obtain

$$e\left(\Phi_{x_{0}}^{0}(x') \cap \mathbb{B}_{r_{x_{0}}}(\bar{x}), \Phi_{x_{0}}^{0}(x'')\right)$$

$$\leq \frac{\kappa}{1-\kappa\lambda} \left(\left\| g_{0}(x'-\bar{x}) - g_{0}(x''-\bar{x}) \right\| + \left\| g_{0}(x'-x_{0}) - g_{0}(x''-x_{0}) \right\| \right)$$

$$\leq \frac{2\kappa\lambda_{0}}{1-\kappa\lambda} \left\| x' - x'' \right\| \leq \frac{2\kappa\lambda}{1-\kappa\lambda} \left\| x' - x'' \right\|.$$
(33)

Then by (14), (33) reduces to

$$e\left(\Phi_{x_{0}}^{0}(x')\cap\mathbb{B}_{r_{x_{0}}}(\bar{x}),\Phi_{x_{0}}^{0}(x'')\right)\leq\frac{2\kappa\lambda}{1-\kappa\lambda}\|x'-x''\|\leq\frac{2}{5}\|x'-x''\|=\alpha\|x'-x''\|.$$

This implies that the assertion (7) of Lemma 3 is also satisfied. Since both assertions (6) and (7) of Lemma 3 are fulfilled, we can deduce there exists a fixed point $\hat{x}_1 \in \mathbb{B}_{r_{x_0}}(\overline{x})$ such that $\hat{x}_1 \in \Phi^0_{x_0}(\hat{x}_1)$, which translates to $Z^0_{x_0}(\hat{x}_1) \in P^0_{\overline{x}}(\hat{x}_1)$, that is, $0 \in g_0(\hat{x}_1 - x_0) + T(\hat{x}_1)$ and hence $D^0(x_0) \neq \emptyset$.

Now, we show that (25) is hold for k = 0.

Note that $\overline{r} > 0$ by assumption (a). Then (13) is valid for (14). Since $P_{\overline{x}}^{k^{-1}}(\cdot)$ is Lipschitz-like at $(\overline{y}, \overline{x})$ on $\mathbb{B}_{r_{\overline{y}}}(\overline{y}) \times \mathbb{B}_{r_{\overline{x}}}(\overline{x})$, it follows from Lemma 4 that the mapping $P_{x}^{k^{-1}}(\cdot)$ is Lipschitz-like at $(\overline{y}, \overline{x})$ on $\mathbb{B}_{\overline{r_{\overline{y}}}}(\overline{y}) \times \mathbb{B}_{\frac{r_{\overline{y}}}{2}}(\overline{x})$ with constant $\frac{\kappa}{1-3\kappa\lambda}$ for each $x \in \mathbb{B}_{\frac{r_{\overline{y}}}{2}}(\overline{x})$. In particular, $P_{x_{0}}^{0^{-1}}(\cdot)$ is Lipschitz-like at

 $(\overline{y},\overline{x})$ on $\mathbb{B}_{\overline{r}}(\overline{y}) \times \mathbb{B}_{\frac{r_{\overline{x}}}{2}}(\overline{x})$ with constant $\frac{\kappa}{1-3\kappa\lambda}$ as $x_0 \in \mathbb{B}_{\hat{\delta}}(\overline{x}) \subset \mathbb{B}_{\delta}(\overline{x}) \subset \mathbb{B}_{\frac{r_{\overline{x}}}{2}}(\overline{x})$ by assumption (a)

and the choice of $\hat{\delta}$. Furthermore, assumptions (a) and (c) imply that

$$\|\overline{y}\| < \lambda \delta \le \overline{r}. \tag{34}$$

It seems that $0 \in \mathbb{B}_{\overline{r}}(\overline{y})$. Then by Lemma 1 we can say that the mapping $P_{x_0}^0(\cdot)$ is metrically regular on $\mathbb{B}_{\frac{r_{\overline{y}}}{2}}(\overline{x})$ relative to $\mathbb{B}_{\overline{r}}(\overline{y})$ with constant $\frac{\kappa}{1-3\kappa\lambda}$. Thus by applying Lemma 1, we have

$$\operatorname{dist}\left(x_{0}, P_{x_{0}}^{0^{-1}}\left(0\right)\right) \leq \frac{\kappa}{1 - 3\kappa\lambda} \operatorname{dist}\left(0, P_{x_{0}}^{0}\left(x_{0}\right)\right)$$
(35)

and (23) implies that

$$\operatorname{dist}\left(x_{0}, P_{x_{0}}^{0^{-1}}\left(0\right)\right) \leq \frac{\kappa}{1 - 3\kappa\lambda} \operatorname{dist}\left(0, P_{x_{0}}^{0}\left(x_{0}\right)\right) = \frac{\lambda\kappa}{1 - 3\kappa\lambda} \operatorname{dist}\left(0, T\left(x_{0}\right)\right) \leq \frac{\lambda\kappa}{1 - 3\kappa\lambda}\delta.$$
(36)

Then from (16) and using (36), we obtain that

$$\operatorname{dist}(0, D^{0}(x_{0})) = \operatorname{dist}(x_{0}, P_{x_{0}}^{0^{-1}}(0)) \leq \frac{\lambda \kappa}{1 - 3\kappa \lambda} \delta.$$

$$(37)$$

From Algorithm 2 and using (21) and (37), we obtain that

$$\|x_1 - x_0\| = \|d_0\| \le \eta \operatorname{dist}\left(0, D^0\left(x_0\right)\right) \le \frac{\eta \kappa \lambda}{1 - 3\kappa \lambda} \delta < t\delta.$$
(38)

This implies that (25) is hold for k = 0.

Suppose that the points x_1, \dots, x_n have been obtained, and (24) and (25) are true for $k = 0, 1, 2, \dots, n-1$. We will show that there exists a point x_{n+1} such that (24) and (25) also hold for k = n. Since (24) and (25) are true for each $k \le n-1$, we have the following inequality

$$\|x_{n} - \overline{x}\| \le \sum_{i=0}^{n-1} \|d_{i}\| + \|x_{0} - \overline{x}\| \le \delta \sum_{i=0}^{n-1} t^{i+1} + \delta \le \frac{\delta t}{1-t} + \delta \le 2\delta.$$
(39)

This reflects that (24) holds for k = n. Now with almost the same argument as we did for the case when k = 0, we can find that the mapping $P_{x_n}^{n^{-1}}(\cdot)$ is also Lipschitz-like at $(\overline{y}, \overline{x})$ on $\mathbb{B}_{\overline{r}}(\overline{y}) \times \mathbb{B}_{\frac{p_{\overline{x}}}{2}}(\overline{x})$ with constant $\frac{\kappa}{1-3\kappa\lambda}$. Then by applying again Algorithm 2, we have

$$\begin{aligned} \|x_{n+1} - x_n\| &= \|d_n\| \le \eta \operatorname{dist}(0, D^n(x_n)) = \eta \operatorname{dist}(x_n, P_{x_n}^{n^{-1}}(0)) \\ &\le \frac{\eta \kappa}{1 - 3\kappa\lambda} \operatorname{dist}(0, P_{x_n}^n(x_n)) = \frac{\eta \kappa}{1 - 3\kappa\lambda} \operatorname{dist}(0, T(x_n)) \\ &= \frac{\eta \kappa}{1 - 3\kappa\lambda} \operatorname{dist}(0, -g_{n-1}(x_n - x_{n-1})) = \frac{\eta \kappa}{1 - 3\kappa\lambda} \|g_{n-1}(0) - g_{n-1}(x_n - x_{n-1})\| \\ &\le \frac{\eta \kappa \lambda_{n-1}}{1 - 3\kappa\lambda} \|x_n - x_{n-1}\| \le \frac{\eta \kappa \lambda}{1 - 3\kappa\lambda} \|x_n - x_{n-1}\| \le \frac{\eta \kappa \lambda}{1 - 3\kappa\lambda} t^n \delta \le t^{n+1} \delta. \end{aligned}$$

$$(40)$$

This shows that (25) holds for k = n. Therefore, the proof is completed.

In the particular case, when \overline{x} is a solution of (1), that is, $\overline{y} = 0$, Theorem 1 is reduced to the following corollary, which gives the local convergence of the sequence generated by the GG-PPA defined by Algorithm 2.

Corollary 1 Suppose that $\eta > 1$ and that \overline{x} satisfies $0 \in T(\overline{x})$ and that $P_{\overline{x}}^{k}(\cdot)$ is metrically regular at $(\overline{x}, 0)$ with constant $\frac{\kappa}{1-\lambda\kappa}$. Let $\tilde{r} > 0$ be such that $\mathbb{B}_{2\tilde{r}}(\overline{x}) \subset O$ and suppose that

$$\lim_{x \to \bar{x}} \operatorname{dist}(0, T(x)) = 0.$$
(41)

Then there exists some $\hat{\delta} > 0$ such that any sequence $\{x_k\}$ generated by Algorithm 2 with initial point in $\mathbb{B}_{\hat{\delta}}(\bar{x})$ converges to a solution x^* of (1), that is, x^* satisfies that $0 \in T(x^*)$.

Proof. Since $P_{\overline{x}}^{k}(\cdot)$ is metrically regular at $(\overline{x}, 0)$, there exist constants r_{0} , $\hat{r}_{\overline{x}}$ and $\frac{\kappa}{1-\kappa\lambda}$ such that $P_{\overline{x}}^{k}(\cdot)$ is metrically regular at $(\overline{x}, 0)$ on $\mathbb{B}_{\hat{r}_{\overline{x}}}(\overline{x}) \times \mathbb{B}_{r_{0}}(0)$ with constant $\frac{\kappa}{1-\kappa\lambda}$. Then, for each $0 < r \le \hat{r}_{\overline{x}}$, one has that

$$\operatorname{dist}\left(x, P_{\overline{x}}^{k^{-1}}\left(y\right)\right) \leq \frac{\kappa}{1 - \kappa\lambda} \operatorname{dist}\left(y, P_{\overline{x}}^{k}\left(x\right)\right) \text{ for all } x \in \mathbb{B}_{r_{\overline{x}}}\left(\overline{x}\right), y \in \mathbb{B}_{r_{0}}\left(0\right).$$

$$(42)$$

Let $\sup_k \lambda_k := \lambda \in (0,1)$ be such that $\kappa \lambda \le \frac{1}{\eta+3}$. Choose $r_{\overline{x}} \in (0,\hat{r}_{\overline{x}})$ such that $\frac{r_{\overline{x}}}{2} \le \tilde{r}$ and $r_0 - \frac{r_{\overline{x}}\lambda}{2} > 0$.

Then

$$\overline{r} = \min\left\{\frac{2r_0 - r_{\overline{x}}\lambda}{2}, \frac{r_{\overline{x}}\left(1 - 3\kappa\lambda\right)}{4\kappa}\right\} > 0,$$
(43)

and

$$\min\left\{\frac{r_{\overline{x}}}{4}, \frac{\overline{r}}{2\lambda}, \frac{r_0}{3\lambda}, \frac{1-\lambda\kappa}{6\kappa\lambda}\right\} > 0.$$
(44)

Thus we can choose $0 < \delta \le 1$ such that

$$\delta \le \min\left\{\frac{r_{\overline{x}}}{4}, \frac{\overline{r}}{2\lambda}, \frac{r_0}{3\lambda}, \frac{1-\lambda\kappa}{6\kappa\lambda}\right\}.$$
(45)

Now it is routine to check that inequalities (a)-(c) of Theorem 1 are hold. Thus Theorem 1 is applicable to complete the proof of the corollary.

4. Numerical Experiment

We will provide, in this section, a numerical example to validate the semilocal convergence results of GG-PPA.

Example 1 Let $X = Y = \mathbb{R}, x_0 = 0.2, \eta = 2, \lambda = 0.2$ and $\kappa = 0.5$. Define a set-valued mapping T on \mathbb{R} by $T(x) = \{-2x+1,1\}$. Consider a sequence of Lipschitz continuous function g_n with $g_n(0) = 0$, which is defined by $g_n(x) = \frac{1}{3}x$. Then Algorithm 2 generates a sequence which is converges to $x^* = 0.5$.

It is obvious from the statement that T is metrically regular at $(0.2, 0.6) \in \text{gph}T$ and g_n is Lipschitz continuous on the neighborhood of 0 with Lipschitz constant $\sup_k \lambda_k := \lambda = 0.2$. Consider T(x) := -2x + 1. Then from (3), we have that

$$D^{k}(x_{k}) = \left\{ d_{k} \in \mathbb{R} : 0 \in g_{k}(d_{k}) + T(x_{k} + d_{k}) \right\}$$
$$= \left\{ d_{k} \in \mathbb{R} : d_{k} = \frac{3 - 6x_{k}}{5} \right\}.$$

On the other hand, if $D^k(x_k) \neq \emptyset$ we obtain that

$$0 \in g_k\left(x_{k+1} - x_k\right) + T\left(x_{k+1}\right) \Longrightarrow x_{k+1} = \frac{3 - x_k}{5}.$$

Thus from (40), we obtain that

$$\left\|d_{k}\right\| \leq \frac{\eta \kappa \lambda}{1 - 3\kappa \lambda} \left\|d_{k-1}\right\|.$$

For the given values of η, λ, κ , we see that $\frac{\eta \kappa \lambda}{1-3\kappa \lambda} = \frac{2}{7} < 1$. Thus, this implies that the sequence generated by **Algorithm 2** converges linearly. Then the following **Table 1**, obtained by using Mat lab program, indicates that the solution of the generalized equation is 0.5 when k = 10.

Moreover, in the case when $T(x) = \{-2x + 1, 1\}$, we can sketch the following Figure 1:

5. Conclusions

In this study, we have established semi-local and local convergence results for the general version of Gauss-type proximal point algorithm for solving generalized equation under the assumptions that $\eta > 1$, a sequence of functions $g_k : X \to Y$ with $g_k(0) = 0$ which is Lipschitz continuous in a neighbourhood O of the origin

and *T* is metrically regular. Moreover, we have presented a numerical experiment to validate the semilocal convergence result for Algorithm 2. For the case where $\eta = 1$, the question, whether the results are true for GG-PPA, is a little bit complicated. However, from the proof of the main theorem, one sees that all the results obtained in the present paper remain true provided that, for any $x \in \Omega \subseteq X$, the following implication holds:

$$D(x) \neq \emptyset \Longrightarrow \exists \overline{d} \in D(x) \text{ such that } \|\overline{d}\| = \min_{d \in D(x)} \|d\|.$$

To see the detail proof of the above implication, one can refer to [17].
