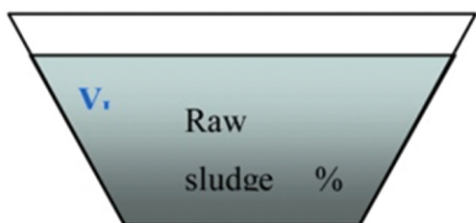

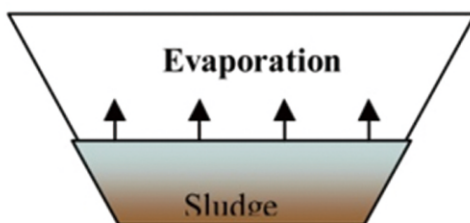

## Drainage Phase

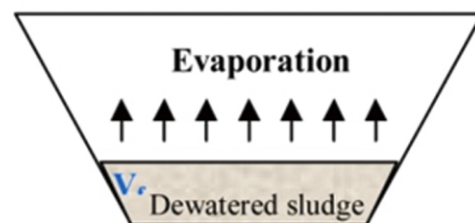
Effect of climatic

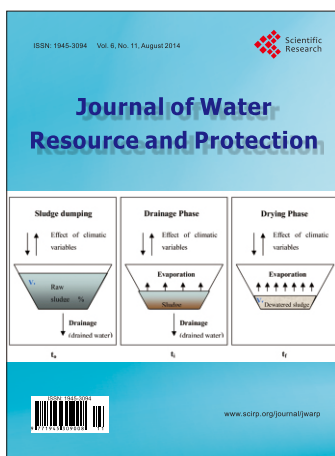
