



Fixed Point Results of Contractive Mappings by Altering Distances and C-Class Functions in b -Dislocated Metric Spaces

Abstract

In this work, we recall definition of functions called as C-class and use the concepts of dislocated metric, b -dislocated metric, altering distance function. We prove some coincidence, fixed and common fixed point results for two pairs of weakly compatible mappings under $f - (\psi, \phi, s)$ -contractive conditions and contractive conditions depended on another function T . Our theorems extend and generalize related results in the literature.

1. Introduction

The study of metric fixed point theory in dislocated metric spaces was considered by P. Hitzler and A. K. Seda in [1] who introduced this metric as a generalization of usual metric, and generalized the Banach contraction principle on this space. Since then a lot of papers have been written on this topic treating the problem of existence and uniqueness of fixed points for mappings satisfying different contractive conditions, see [2]-[14]. N. Hussain *et al.* in [15] introduced the b -dislocated metric spaces associated with some topological aspects and properties. These spaces can be seen as generalizations of dislocated metric

spaces and also as generalization of b -metric space introduced by Bakhtin in [16] and extensively used by Czerwik in [8]. Recently, there are many papers on existence and uniqueness of fixed point and common fixed point for one, two or more mappings under different types of contractive conditions in the setting of dislocated spaces and b -dislocated metric spaces.

Since altering distance functions were introduced by Khan *et al.* in [17], the study of the existence of fixed points of contractive maps in metric spaces and generalized metric spaces has a lot of interest for many authors which are based on this category of functions (see [17]-[23]). In September 2014, a class of functions called as C-class is presented by A. H. Ansari, see in [24] [25] and is important, see example 2.15.

The present paper is organized in two sections. Using concepts mentioned above, in the first section, we develop some coincidence and common fixed point theorems (existence and uniqueness) for two pairs of weakly compatible mappings in the framework of b_d -dislocated metric space, using weak generalized $f - (\psi, \phi, s)$ contractive conditions. In the second section, we prove common fixed point theorems for a pair of mappings using generalized $f - (\psi, \phi, s)$ contractive condition and the concept of T -contractions. The related results generalize and improve various theorems in recent literature.

2. Preliminaries

Consistent with [1] and [15], the following definitions, notations, basic lemma and remarks will be needed in the sequel.

Definition 2.1 [1] Let X be a nonempty set and a mapping $d_l : X \times X \rightarrow [0, \infty)$ is called a dislocated metric (or simply d_l -metric) if the following conditions hold for any $x, y, z \in X$:

- 1) If $d_l(x, y) = 0$, then $x = y$
- 2) $d_l(x, y) = d_l(y, x)$
- 3) $d_l(x, y) \leq d_l(x, z) + d_l(z, y)$

The pair (X, d_l) is called a dislocated metric space (or d -metric space for short). Note that for $x = y$, $d_l(x, y)$ may not be 0.

Definition 2.2 [15] Let X be a nonempty set and a mapping $b_d : X \times X \rightarrow [0, \infty)$ is called a b -dislocated metric (or simply b_d -dislocated metric) if the following conditions hold for any $x, y, z \in X$ and $s \geq 1$:

- 1) If $b_d(x, y) = 0$, then $x = y$
- 2) $b_d(x, y) = b_d(y, x)$
- 3) $b_d(x, y) \leq s[b_d(x, z) + b_d(z, y)]$

The pair (X, b_d) is called a b -dislocated metric space. And the class of b -dislocated metric space is larger than that of dislocated metric spaces, since a b -dislocated metric is a dislocated metric when $s = 1$.

Example 2.3 If $X = \mathbb{R}$, then $d_l(x, y) = |x| + |y|$ defines a dislocated metric on X .

Definition 2.4 [1] A sequence (x_n) in d_l -metric space (X, d_l) is called:

1) a Cauchy sequence if, for given $\varepsilon > 0$, there exists $n_0 \in \mathbb{N}$ such that for all $m, n \geq n_0$, we have or $\lim_{n,m \rightarrow \infty} d_l(x_n, x_m) = 0$;

2) convergent with respect to d_l if there exists $x \in X$ such that $d_l(x_n, x) \rightarrow 0$ as $n \rightarrow \infty$. In this case, x is called the limit of (x_n) and we write $x_n \rightarrow x$.

A d_l -metric space X is called complete if every Cauchy sequence in X converges to a point in X .

In [15], it was shown that each b_d -metric on X generates a topology τ_{b_d} whose base is the family of open b_d -balls $B_{b_d}(x, \varepsilon) = \{y \in X : b_d(x, y) < \varepsilon\}$.

Also in [15], there are presented some topological properties of b_d -metric spaces.

Definition 2.5 [15] Let (X, b_d) be a b_d -metric space, and $\{x_n\}$ be a sequence of points in X . A point $x \in X$ is said to be the limit of the sequence $\{x_n\}$ if $\lim_{n \rightarrow \infty} b_d(x_n, x) = 0$ and we say that the sequence $\{x_n\}$ is b_d -convergent to x and denote it by $x_n \rightarrow x$ as $n \rightarrow \infty$.

The limit of a b_d -convergent sequence in a b_d -metric space is unique ([15], Proposition 1.27).

Definition 2.6 [15] A sequence $\{x_n\}$ in a b_d -metric space (X, b_d) is called a b_d -Cauchy sequence if, given $\varepsilon > 0$, there exists $n_0 \in \mathbb{N}$ such that for all $n, m > n_0$, we have $b_d(x_n, x_m) < \varepsilon$ or $\lim_{n,m \rightarrow \infty} b_d(x_n, x_m) = 0$. Every b_d -convergent sequence in a b_d -metric space is a b_d -Cauchy sequence.

Remark 2.7 The sequence $\{x_n\}$ in a b_d -metric space (X, b_d) is called a b_d -Cauchy sequence if $\lim_{n,m \rightarrow \infty} b_d(x_n, x_{n+p}) = 0$ for all $p \in \mathbb{N}^*$.

Definition 2.8 [15] A b_d -metric space (X, b_d) is called complete if every b_d -Cauchy sequence in X is b_d -convergent.

Example 2.9 If $X = \mathbb{R}^+ \cup \{0\}$, then $b_d(x, y) = (x + y)^2$ defines a b -dislocated metric on X with parameter $s = 2$.

Example 2.10 Let $X = \mathbb{R}^+ \cup \{0\}$ and any constant $\alpha > 0$. Define function $d_l : X \times X \rightarrow \mathbb{R}^+$ by $d_l(x, y) = \alpha(x + y)$. Then, the pair (X, d_l) is a dislocated metric space.

If $Fx = Sx$ for some $x \in X$, then x is called the coincidence point of F and S . Furthermore, if the mappings commute at each coincidence point, then such mappings are called weakly compatible [4].

Definition 2.11 [17] The altering distances functions ψ and ϕ are defined as

$$\Psi = \{\psi : [0, \infty) \rightarrow [0, \infty) / \psi \text{ is continuous, nondecreasing, and } \psi(t) = 0 \text{ if } t = 0\}$$

$$\Phi = \{\phi : [0, \infty) \rightarrow [0, \infty) / \phi \text{ is lower semicontinuous, and } \phi(t) = 0 \text{ if } t = 0\}$$

The following lemmas are used to prove our results.

Lemma 2.12 Let (X, b_d) be a b -dislocated metric space with parameter $s \geq 1$. Then

- 1) If $b_d(x, y) = 0$ then $b_d(x, x) = b_d(y, y) = 0$;
- 2) If (x_n) is a sequence such that $\lim_{n \rightarrow \infty} b_d(x_n, x_{n+1}) = 0$, then we have

$$\lim_{n \rightarrow \infty} b_d(x_n, x_n) = \lim_{n \rightarrow \infty} b_d(x_{n+1}, x_{n+1}) = 0;$$

3) If $x \neq y$, then $b_d(x, y) > 0$;

Proof. It is clear.

Lemma 2.13 [15] Let (X, b_d) be a b -dislocated metric space with parameter $s \geq 1$. Suppose that $\{x_n\}$ and $\{y_n\}$ are b_d -convergent to $x, y \in X$, respectively. Then we have

$$\frac{1}{s^2} b_d(x, y) \leq \liminf_{n \rightarrow \infty} b_d(x_n, y_n) \leq \limsup_{n \rightarrow \infty} b_d(x_n, y_n) \leq s^2 b_d(x, y)$$

In particular, if $b_d(x, y) = 0$, then we have $\lim_{n \rightarrow \infty} b_d(x_n, y_n) = 0 = b_d(x, y)$. Moreover, for each $z \in X$, we have

$$\frac{1}{s} b_d(x, z) \leq \liminf_{n \rightarrow \infty} b_d(x_n, z) \leq \limsup_{n \rightarrow \infty} b_d(x_n, z) \leq s b_d(x, z)$$

In particular, if $b_d(x, z) = 0$, then we have $\lim_{n \rightarrow \infty} b_d(x_n, z) = 0 = b_d(x, z)$.

Definition 2.14. [24] [25] We say that a function $f : [0, \infty)^2 \rightarrow R$ is called a C -class function if it is continuous and satisfies the following properties.

- 1) $f(s, t) \leq s$
- 2) $f(s, t) = s \Rightarrow s = 0$ or $t = 0$ for all $s, t \in [0, \infty)$
- 3) $f(0, 0) = 0$

We denote C -class functions as C .

Example 2.15 [24] [25] The following functions $f : [0, \infty)^2 \rightarrow R$ are elements of C , for all $s, t \in [0, \infty)$:

- 1) $f(s, t) = s - t, f(s, t) = s \Rightarrow t = 0$
- 2) $f(s, t) = \frac{s-t}{1+t}, f(s, t) = s \Rightarrow t = 0$
- 3) $f(s, t) = \frac{st}{1+t}, f(s, t) = s \Rightarrow s = 0$
- 4) $f(s, t) = \frac{s}{1+t}, f(s, t) = s \Rightarrow s = 0$ or $t = 0$
- 5) $f(s, t) = \log \frac{t+a^s}{1+t}, a > 1, f(s, t) = s \Rightarrow s = 0$ or $t = 0$

For $t = 1$, we have $f(s, 1) = \ln \frac{1+a^s}{2}, a > e, f(s, 1) = s \Rightarrow s = 0$

- 6) $f(s, t) = (s+k)^{\frac{1}{1+t}} - k, k > 1, f(s, t) = s \Rightarrow t = 0$
- 7) $f(s, t) = s \log_{a+t} a, a > 1, f(s, t) = s \Rightarrow s = 0$ or $t = 0$
- 8) $f(s, t) = ms, 0 < m < 1, f(s, t) = s \Rightarrow s = 0$
- 9) $f(s, t) = \phi(s), f(s, t) = s \Rightarrow s = 0$, here $\phi : [0, \infty) \rightarrow [0, \infty)$ is continuous and such that $\phi(0) = 0$ and $\phi(t) < t$ for $t > 0$.

3. Main Results

Before we give the main result we denote with letter $N(x, y)$ the following set

$$N(x, y) = \max \{b_d(Sx, Ty), b_d(Fx, Sx), b_d(Gy, Ty), b_d(Sx, Gy), b_d(Fx, Ty)\} \tag{3.1.1}$$

for all $x, y \in X$.

Motivated by the works of [15] [21]-[29] we extend the concept of (ψ, ϕ) -weakly contractive maps to four maps in a b -dislocated metric space, giving the following definition.

Definition 3.1 Let F, G, S, T be four self maps of a b -dislocated metric space (X, b_d) with parameter $s \geq 1$. If there exists $\psi \in \Psi$, $\phi \in \Phi$ and $f \in C$ such that

$$\psi(2s^4 b_d(Fx, Gy)) \leq f(\psi(N(x, y)), \phi(N(x, y))) \tag{A}$$

for all $x, y \in X$, where $N(x, y)$ is defined as in (3.1.1) then F, G, S and T are said to satisfy a generalized $f - (\psi, \phi, s)$ weakly contractive condition.

Theorem 3.2 Let (X, b_d) be a b -dislocated metric space with parameter $s \geq 1$ and $S, T, F, G : X \rightarrow X$ are self-mappings such that (a) $F(X) \subset T(X)$, $G(X) \subset S(X)$ and satisfy generalized $f - (\psi, \phi, s)$ weakly contractive condition. If one of $F(X), S(X), T(X)$ or $G(X)$ is a complete subspace of X , then (F, S) and (G, T) have a point of coincidence in X . Moreover if suppose that (F, S) and (G, T) are weakly compatible pairs, then F, G, S, T have a unique common fixed point.

Proof. Let x_0 be an arbitrary point in X . Since $F(X) \subset T(X)$ we can choose $x_1 \in X$ such that $y_0 = fx_0 = Tx_1$. And since $G(X) \subset S(X)$ corresponding to $x_1 \in X$ we can choose $x_2 \in X$ such that $y_1 = Gx_1 = Sx_2$. Continuing the same process we obtain sequences $\{x_n\}$ and $\{y_n\}$ in X such that:

$$y_{2n} = Fx_{2n} = Tx_{2n+1}; y_{2n+1} = Gx_{2n+1} = Sx_{2n+2} \text{ for all } n = 0, 1, 2, \dots$$

We consider following steps:

Step 1. If $y_{2n} = y_{2n+1}$ (that means $b_d(y_{2n}, y_{2n+1}) = 0$) for some n , then $Gx_{2n+1} = Tx_{2n+1}$. Hence x_{2n+1} is a coincidence point of G and T . Using definition of $N(x, y)$ and lemma 2.12 we have,

$$\begin{aligned} &N(x_{2n+2}, x_{2n+1}) \\ &= \max \{b_d(Sx_{2n+2}, Tx_{2n+1}), b_d(Fx_{2n+2}, Sx_{2n+2}), b_d(Gx_{2n+1}, Tx_{2n+1}), \\ &\quad b_d(Sx_{2n+2}, Gx_{2n+1}), b_d(Fx_{2n+2}, Tx_{2n+1})\} \\ &= \max \{b_d(y_{2n+1}, y_{2n}), b_d(y_{2n+2}, y_{2n+1}), b_d(y_{2n+1}, y_{2n}), \\ &\quad b_d(y_{2n+1}, y_{2n+1}), b_d(y_{2n+2}, y_{2n})\} \\ &\leq \max \{b_d(y_{2n+1}, y_{2n}), b_d(y_{2n+2}, y_{2n+1}), b_d(y_{2n+1}, y_{2n}), \\ &\quad 2sb_d(y_{2n+1}, y_{2n}), s[b_d(y_{2n+2}, y_{2n+1}) + b_d(y_{2n+1}, y_{2n})]\} \\ &= \max \{0, b_d(y_{2n+2}, y_{2n+1}), 0, 0, sb_d(y_{2n+2}, y_{2n+1})\} \\ &= sb_d(y_{2n+2}, y_{2n+1}) \end{aligned}$$

$$\text{Thus } N(x_{2n+2}, x_{2n+1}) \leq sb_d(y_{2n+2}, y_{2n+1}) \tag{3.2.1}$$

Using condition (A) and property of C-class, we have that

$$\begin{aligned} \psi(sb_d(y_{2n+1}, y_{2n+2})) &= \psi(sb_d(Gx_{2n+1}, Fx_{2n+2})) \\ &= \psi(2sb_d(Fx_{2n+2}, Gx_{2n+1})) \\ &\leq \psi(2s^4b_d(Fx_{2n+2}, Gx_{2n+1})) \\ &\leq f(\psi(N(x_{2n+2}, x_{2n+1})), \phi(N(x_{2n+2}, x_{2n+1}))) \\ &\leq \psi(N(x_{2n+2}, x_{2n+1})) \end{aligned}$$

By property of ψ we have,

$$sb_d(y_{2n+2}, y_{2n+1}) \leq N(x_{2n+2}, x_{2n+1}) \tag{3.2.2}$$

As a result we get,

$$N(x_{2n+2}, x_{2n+1}) = sb_d(y_{2n+1}, y_{2n+2}).$$

Again from contractive condition of theorem have,

$$\begin{aligned} \psi(sb_d(y_{2n+2}, y_{2n+1})) &= \psi(sb_d(Fx_{2n+2}, Gx_{2n+1})) \\ &\leq \psi(2s^4b_d(Fx_{2n+2}, Gx_{2n+1})) \\ &\leq f(\psi(N(x_{2n+2}, x_{2n+1})), \phi(N(x_{2n+2}, x_{2n+1}))) \\ &= f(\psi(sb_d(y_{2n+1}, y_{2n+2})), \phi(sb_d(y_{2n+1}, y_{2n+2}))) \\ &\leq \psi(sb_d(y_{2n+1}, y_{2n+2})) \end{aligned}$$

The inequality above implies,

$$f(\psi(sb_d(y_{2n+1}, y_{2n+2})), \phi(sb_d(y_{2n+1}, y_{2n+2}))) = \psi(sb_d(y_{2n+1}, y_{2n+2}))$$

By property of function f of C-class we obtain

$$\psi(sb_d(y_{2n+1}, y_{2n+2})) = 0 \text{ or } \phi(sb_d(y_{2n+1}, y_{2n+2})) = 0.$$

And also by property of ψ, ϕ we get $b_d(y_{2n+1}, y_{2n+2}) = 0$ so that $y_{2n+1} = y_{2n+2}$ and then $Fx_{2n+2} = Sx_{2n+2}$. Also x_{2n+2} is a coincidence point of F and S .

Step 2. Suppose $y_{2n} \neq y_{2n+1}$ that means $b_d(y_{2n}, y_{2n+1}) > 0$ for all n by condition (3.1.1) we have:

$$\begin{aligned} N(x_{2n}, x_{2n+1}) &= \max\{b_d(Sx_{2n}, Tx_{2n+1}), b_d(Fx_{2n}, Sx_{2n}), b_d(Gx_{2n+1}, Tx_{2n+1}) \\ &\quad b_d(Sx_{2n}, Gx_{2n+1}), b_d(Fx_{2n}, Tx_{2n+1})\} \\ &= \max\{b_d(y_{2n-1}, y_{2n}), b_d(y_{2n}, y_{2n-1}), b_d(y_{2n+1}, y_{2n}) \\ &\quad b_d(y_{2n-1}, y_{2n+1}), b_d(y_{2n}, y_{2n})\} \\ &\leq \max\{b_d(y_{2n-1}, y_{2n}), b_d(y_{2n}, y_{2n-1}), b_d(y_{2n+1}, y_{2n}) \\ &\quad s[b_d(y_{2n-1}, y_{2n}) + b_d(y_{2n}, y_{2n+1})], 2sb_d(y_{2n}, y_{2n+1})\} \\ &\leq \max\{2sb_d(y_{2n}, y_{2n+1}), 2sb_d(y_{2n-1}, y_{2n})\} \end{aligned}$$

$$\text{If } b_d(y_{2n-1}, y_{2n}) < b_d(y_{2n}, y_{2n+1}) \text{ then } N(x_{2n}, x_{2n+1}) \leq 2sb_d(y_{2n}, y_{2n+1}) \tag{3.2.3}$$

Also from condition of theorem we have:

$$\begin{aligned} \psi(2sb_d(y_{2n}, y_{2n+1})) &\leq \psi(2s^4b_d(y_{2n}, y_{2n+1})) \\ &= \psi(2s^4b_d(Fx_{2n}, Gx_{2n+1})) \\ &\leq f(\psi(N(x_{2n}, x_{2n+1})), \phi(N(x_{2n}, x_{2n+1}))) \\ &\leq \psi(N(x_{2n}, x_{2n+1})) \end{aligned}$$

By property of function ψ we have

$$2sb_d(y_{2n}, y_{2n+1}) \leq N(x_{2n}, x_{2n+1}) \tag{3.2.4}$$

From (3.2.3) and (3.2.4) we get

$$N(x_{2n}, x_{2n+1}) = 2sb_d(y_{2n}, y_{2n+1}) \tag{3.2.5}$$

Also from condition of theorem and (3.2.5) we have,

$$\begin{aligned} \psi(2sb_d(y_{2n}, y_{2n+1})) &\leq \psi(2s^4b_d(y_{2n}, y_{2n+1})) \\ &= \psi(2s^4b_d(Fx_{2n}, Gx_{2n+1})) \\ &\leq f(\psi(N(x_{2n}, x_{2n+1})), \phi(N(x_{2n}, x_{2n+1}))) \\ &= f(\psi(2sb_d(y_{2n}, y_{2n+1})), \phi(2sb_d(y_{2n}, y_{2n+1}))) \\ &\leq \psi(2sb_d(y_{2n}, y_{2n+1})) \end{aligned}$$

The above inequality implies:

$$\begin{aligned} \psi(2sb_d(y_{2n}, y_{2n+1})) &\leq f(\psi(2sb_d(y_{2n}, y_{2n+1})), \phi(2sb_d(y_{2n}, y_{2n+1}))) \\ &\leq \psi(2sb_d(y_{2n}, y_{2n+1})) \end{aligned}$$

which means

$$f(\psi(2sb_d(y_{2n}, y_{2n+1})), \phi(2sb_d(y_{2n}, y_{2n+1}))) = \psi(2sb_d(y_{2n}, y_{2n+1})).$$

From property of C-class we obtain

$$\psi(2sb_d(y_{2n}, y_{2n+1})) = 0 \text{ or } \phi(2sb_d(y_{2n}, y_{2n+1})) = 0.$$

So we have $b_d(y_{2n}, y_{2n+1}) = 0$ that is a contradiction since we suppose $b_d(y_{2n}, y_{2n+1}) > 0$.

So we have $b_d(y_{2n}, y_{2n+1}) \leq b_d(y_{2n-1}, y_{2n})$.

In a similar way as above we have $b_d(y_{2n+1}, y_{2n+2}) \leq b_d(y_{2n}, y_{2n+1})$. As a result the sequence $\{b_d(y_n, y_{n+1})\}$ is non increasing and bounded below. And so there exists $l \geq 0$ such that,

$$\lim_{n \rightarrow \infty} b_d(y_n, y_{n+1}) = \lim_{n \rightarrow \infty} N(x_n, x_{n+1}) = l.$$

Suppose that $l > 0$. Since ψ is continuous and ϕ is lower semi continuous we have:

$$\psi(l) = \lim_{n \rightarrow \infty} \psi(N(x_n, x_{n+1})) \text{ and } \phi(l) \leq \liminf_{n \rightarrow \infty} \phi(N(x_n, x_{n+1})) \tag{3.2.6}$$

If we consider condition (A) we have,

$$\begin{aligned} \psi(2sb_d(y_{2n+2}, y_{2n+1})) &\leq \psi(2s^4b_d(y_{2n+2}, y_{2n+1})) \\ &\leq f(\psi(N(x_{2n+2}, x_{2n+1})), \phi(N(x_{2n+2}, x_{2n+1}))) \quad (3.2.7) \\ &\leq \psi(N(x_{2n+2}, x_{2n+1})) \end{aligned}$$

taking the upper limit as $n \rightarrow \infty$ in (3.2.7) and using (3.2.6) we have that,

$$\begin{aligned} \psi(2sl) &\leq f(\psi(2sl), \phi(2sl)) \leq \psi(2sl) \\ \Rightarrow f(\psi(2sl), \phi(2sl)) &= \psi(2sl) \quad (3.2.8) \\ \Rightarrow \psi(2sl) &= 0 \text{ or } \phi(2sl) = 0. \end{aligned}$$

From (3.2.8) and property of ψ we get $l = 0$ that is a contradiction. Hence

$$\lim_{n \rightarrow \infty} b_d(y_n, y_{n+1}) = \lim_{n \rightarrow \infty} N(x_n, x_{n+1}) = 0 \quad (3.2.9)$$

Now we prove that $\{y_n\}$ is a b_d -Cauchy sequence. Assume the contrary that $\{y_{2n}\}$ is not a b_d -Cauchy sequence. Then there exists $\varepsilon > 0$ for which we can find subsequences $\{y_{2m_k}\}$ and $\{y_{2n_k}\}$ of $\{y_{2n}\}$ so that n_k is the smallest index for which $2n_k > 2m_k > k$, that

$$b_d(y_{2m_k}, y_{2n_k}) \geq \varepsilon \quad (3.1.10)$$

$$\text{and } b_d(y_{2m_k}, y_{2n_k-2}) < \varepsilon \quad (3.2.11)$$

From property c) of definition 2.2 we have:

$$\begin{aligned} \varepsilon \leq b_d(y_{2m_k}, y_{2n_k}) &\leq sb_d(y_{2m_k}, y_{2n_k-2}) + sb_d(y_{2n_k-2}, y_{2n_k}) \\ &\leq sb_d(y_{2m_k}, y_{2n_k-2}) + s^2b_d(y_{2n_k-2}, y_{2n_k-1}) + s^2b_d(y_{2n_k-1}, y_{2n_k}) \end{aligned} \quad (3.2.12)$$

Taking the upper limit as $k \rightarrow \infty$ in (3.2.12) and using result (3.129) and (3.2.11), we get

$$\varepsilon \leq \limsup_{k \rightarrow \infty} b_d(y_{2m_k}, y_{2n_k}) \leq \varepsilon s \quad (3.2.13)$$

Also we have

$$\varepsilon \leq b_d(y_{2m_k}, y_{2n_k}) \leq sb_d(y_{2m_k}, y_{2n_k-1}) + sb_d(y_{2n_k-1}, y_{2n_k}) \quad (3.2.14)$$

Hence taking the upper limit in above inequality, we obtain

$$\frac{\varepsilon}{s} \leq \limsup_{k \rightarrow \infty} b_d(y_{2m_k}, y_{2n_k-1}) \quad (3.2.15)$$

Again from property c) of definition 2.2, we have

$$b_d(y_{2m_k}, y_{2n_k-1}) \leq sb_d(y_{2m_k}, y_{2n_k}) + sb_d(y_{2n_k}, y_{2n_k-1}) \quad (3.2.16)$$

Thus from 3.2.9; 3.2.15 we have

$$\limsup_{k \rightarrow \infty} b_d(y_{2m_k}, y_{2n_k-1}) \leq \varepsilon s^2 \quad (3.2.17)$$

As a result,

$$\frac{\varepsilon}{s} \leq \limsup_{k \rightarrow \infty} b_d(y_{2m_k}, y_{2n_k-1}) \leq \varepsilon s^2 \quad (3.2.18)$$

Similarly,

$$\varepsilon \leq b_d(y_{2m_k}, y_{2n_k}) \leq sb_d(y_{2m_k}, y_{2m_k+1}) + sb_d(y_{2m_k+1}, y_{2n_k}) \quad (3.2.19)$$

Taking the upper limit in (3.2.19) and using 3.2.9, we get

$$\frac{\varepsilon}{s} \leq \limsup_{k \rightarrow \infty} b_d(y_{2m_k+1}, y_{2n_k}) \quad (3.2.20)$$

Similarly,

$$\begin{aligned} \varepsilon &\leq b_d(y_{2m_k}, y_{2n_k}) \leq sb_d(y_{2m_k}, y_{2m_k+1}) + sb_d(y_{2m_k+1}, y_{2n_k}) \\ &\leq sb_d(y_{2m_k}, y_{2m_k+1}) + s^2 b_d(y_{2m_k+1}, y_{2n_k-1}) + s^2 b_d(y_{2n_k-1}, y_{2n_k}) \end{aligned}$$

Taking the upper limit in above inequality and using (3.2.9), we have

$$\frac{\varepsilon}{s^2} \leq \limsup_{k \rightarrow \infty} b_d(y_{2m_k+1}, y_{2n_k-1}) \quad (3.2.21)$$

Also,

$$b_d(y_{2m_k+1}, y_{2n_k-1}) \leq sb_d(y_{2m_k+1}, y_{2m_k}) + sb_d(y_{2m_k}, y_{2n_k-1})$$

Taking the upper limit and using 3.2.9; 3.2.18 we get

$$\limsup_{k \rightarrow \infty} b_d(y_{2m_k+1}, y_{2n_k-1}) \leq \varepsilon s^3 \quad (3.2.22)$$

So, by (3.2.21) and (3.2.22) we have

$$\frac{\varepsilon}{s^2} \leq \limsup_{k \rightarrow \infty} b_d(y_{2m_k+1}, y_{2n_k-1}) \leq \varepsilon s^3 \quad (3.2.23)$$

According to the set (3.1.1) we have:

$$\begin{aligned} N(x_{2n_k}, x_{2m_k+1}) &= \max \left\{ b_d(Sx_{2n_k}, Tx_{2m_k+1}), b_d(Fx_{2n_k}, Sx_{2n_k}), b_d(Gx_{2m_k+1}, Tx_{2m_k+1}), \right. \\ &\quad \left. b_d(Sx_{2n_k}, Gx_{2m_k+1}), b_d(Fx_{2n_k}, Tx_{2m_k+1}) \right\} \\ &= \max \left\{ b_d(y_{2n_k-1}, y_{2m_k}), b_d(y_{2n_k}, y_{2n_k-1}), b_d(y_{2m_k+1}, y_{2m_k}), \right. \\ &\quad \left. b_d(y_{2n_k-1}, y_{2m_k+1}), b_d(y_{2n_k}, y_{2m_k}) \right\} \end{aligned} \quad (3.2.24)$$

Taking the upper limit in (3.2.24) and using results 3.2.9; 3.2.18; 3.2.13; 3.2.23 we get

$$\begin{aligned} &\limsup_{k \rightarrow \infty} N(x_{2n_k}, x_{2m_k+1}) \\ &= \limsup_{k \rightarrow \infty} \max \left\{ b_d(y_{2n_k-1}, y_{2m_k}), b_d(y_{2n_k}, y_{2n_k-1}), b_d(y_{2m_k+1}, y_{2m_k}), \right. \\ &\quad \left. b_d(y_{2n_k-1}, y_{2m_k+1}), b_d(y_{2n_k}, y_{2m_k}) \right\} \\ &\leq \max \{ \varepsilon s^2, 0, 0, \varepsilon s, \varepsilon s^3 \} \end{aligned} \quad (3.2.25)$$

Similarly, we can show,

$$\min \left\{ \frac{\varepsilon}{s}, \varepsilon, \frac{\varepsilon}{s^2} \right\} \leq \liminf_{k \rightarrow \infty} N(x_{2n_k}, x_{2m_k+1}) \leq \varepsilon s^3 \quad (3.2.26)$$

From contractive condition of theorem, we have

$$\begin{aligned} \psi\left(2s^4 b_d\left(y_{2n_k}, y_{2m_k+1}\right)\right) &\leq \psi\left(2s^4 b_d\left(Fx_{2n_k}, Gx_{2m_k+1}\right)\right) \\ &\leq f\left(\psi\left(N\left(x_{2n_k}, x_{2m_k+1}\right)\right), \phi\left(N\left(x_{2n_k}, x_{2m_k+1}\right)\right)\right) \\ &\leq \psi\left(N\left(x_{2n_k}, x_{2m_k+1}\right)\right) \end{aligned} \tag{3.2.27}$$

Taking the upper limit as $k \rightarrow \infty$ in (3.2.27) and using 3.2.25; 3.2.26, we obtain

$$\begin{aligned} \psi\left(2\varepsilon s^3\right) &= \psi\left(2s^4 \frac{\varepsilon}{s}\right) \leq \psi\left(2s^4 \limsup_{k \rightarrow \infty} b_d\left(y_{2n_k}, y_{2m_k+1}\right)\right) \\ &= \psi\left(2s^4 \limsup_{k \rightarrow \infty} b_d\left(Fx_{2n_k}, Gx_{2m_k+1}\right)\right) \\ &\leq f\left(\psi\left(\limsup_{k \rightarrow \infty} N\left(x_{2n_k}, x_{2m_k+1}\right)\right), \phi\left(\liminf_{k \rightarrow \infty} N\left(x_{2n_k}, x_{2m_k+1}\right)\right)\right) \\ &\leq f\left(\psi\left(\varepsilon s^3\right), \phi\left(\varepsilon s^3\right)\right) \leq \psi\left(\varepsilon s^3\right) \end{aligned}$$

From this inequality and since ψ is non decreasing follows that

$$2\varepsilon s^3 \leq \varepsilon s^3 \Leftrightarrow \varepsilon s^3 = 0 \Leftrightarrow \varepsilon = 0.$$

That is a contradiction since we supposed $\varepsilon > 0$. Thus $\{y_n\}$ is a b_d -Cauchy sequence in b-dislocated metric space (X, b_d) . Also the subsequences $\{fx_{2n}\}$, $\{Tx_{2n+1}\}$, $\{Gx_{2n+1}\}$, $\{Sx_{2n+2}\}$ are b_d -Cauchy. Let we suppose that $F(X)$ is a complete subspace of X , since the subsequence $\{fx_{2n}\}$ is b_d -Cauchy then there exists $z \in F(X)$ such that $\lim_{n \rightarrow \infty} y_{2n} = \lim_{n \rightarrow \infty} Fx_{2n} = z$. Then we have,

$$\lim_{n \rightarrow \infty} Tx_{2n+1} = \lim_{n \rightarrow \infty} Fx_{2n} = \lim_{n \rightarrow \infty} Gx_{2n+1} = \lim_{n \rightarrow \infty} Sx_{2n+2} = z. \tag{3.2.28}$$

Since $z \in F(X) \subset T(X)$, then there exists $y \in X$ such that $Ty = z$. According to (3.1.1) consider

$$\begin{aligned} &N(x_{2n}, y) \\ &= \max\{b_d(Sx_{2n}, Ty), b_d(Fx_{2n}, Sx_{2n}), b_d(Gy, Ty), b_d(Sx_{2n}, Gy), b_d(Fx_{2n}, Ty)\} \\ &= \max\{b_d(y_{2n-1}, z), b_d(y_{2n}, y_{2n-1}), b_d(Gy, z), b_d(y_{2n-1}, Gy), b_d(y_{2n}, z)\} \end{aligned} \tag{3.2.29}$$

Taking the upper limit and using lemma 2.13, result (3.2.9) and (3.2.28) we obtain

$$\limsup_{n \rightarrow \infty} N(x_{2n}, y) \leq sb_d(Gy, z) \tag{3.2.30}$$

Using contractive condition (A) of theorem we have,

$$\begin{aligned} \psi\left(2s^4 b_d\left(Fx_{2n}, Gy\right)\right) &\leq f\left(\psi\left(N\left(x_{2n}, y\right)\right), \phi\left(N\left(x_{2n}, y\right)\right)\right) \\ &\leq \psi\left(N\left(x_{2n}, y\right)\right) \end{aligned} \tag{3.2.31}$$

Taking the upper limit in (3.2.31) and using (3.2.30) we get

$$\psi\left(2s^3 b_d(z, Gy)\right) = \psi\left(2s^4 \frac{1}{s} b_d(z, Gy)\right) \leq \psi\left(sb_d(Gy, z)\right)$$

This implies $b_d(z, Gy) = 0$ and so $Gy = z$. Thus $Gy = Ty = z$, so y is a point

of coincidence of the pair (G, T) .

Similarly we can show that $Fv = Sv = z$, so v is a point of coincidence of the pair (F, S) . Therefore we have

$$Gy = Ty = Fv = Sv = z. \tag{3.2.32}$$

Let show that z is a unique point of coincidence of pairs (F, S) and (G, T) . Suppose that exists another point $z_1 \in X$ such that $Gz_1 = Ty_1 = Fv_1 = Sv_1 = z_1$.

We consider,

$$\begin{aligned} N(z, z_1) &= \max \{b_d(Sz, Tz_1), b_d(Fz, Sz), b_d(Gz_1, Tz_1), b_d(Sz, Gz_1), b_d(Fz, Tz_1)\} \\ &= \max \{b_d(z, z_1), b_d(z, z), b_d(z_1, z_1), b_d(z, z_1), b_d(z, z_1)\} \\ &\leq 2sb_d(z, z_1) \end{aligned}$$

Using contractive condition of theorem we have,

$$\begin{aligned} \psi(2s^4b_d(z, z_1)) &= \psi(2s^4b_d(Fz, Gz_1)) \\ &\leq f(\psi(N(z, z_1)), \phi(N(z, z_1))) \\ &\leq \psi(N(z, z_1)) \\ &\leq \psi(2sb_d(z, z_1)) \end{aligned}$$

The inequality above implies that $b_d(z, z_1) = 0$ so $z = z_1$ that means the point of coincidence is unique.

Let prove that z is a common fixed point. By the weak compatibility of the pairs (F, S) and (G, T) have: $Sz = SFv = FSv = Fz$ and $Gz = GTy = TGy = Tz$.

From condition of theorem we have,

$$\begin{aligned} \psi(2sb_d(Fz, Gz)) &\leq \psi(2s^4b_d(Fz, Gz)) = \psi(2s^4b_d(Fz, Gz)) \\ &\leq f(\psi(N(z, z)), \phi(N(z, z))) \\ &\leq \psi(N(z, z)) \end{aligned} \tag{3.2.33}$$

This inequality implies $2sb_d(Fz, Gz) \leq N(z, z)$.

And

$$\begin{aligned} N(z, z) &= \max \{b_d(Sz, Tz), b_d(Fz, Sz), b_d(Gz, Tz), b_d(Sz, Gz), b_d(Fz, Tz)\} \\ &= \max \{b_d(Fz, Gz), b_d(Fz, Fz), b_d(Gz, Gz), b_d(Fz, Gz), b_d(Fz, Gz)\} \\ &\leq 2sb_d(Fz, Gz) \end{aligned} \tag{3.2.34}$$

Again from (3.2.33) and (3.2.34) we get, $N(z, z) = 2sb_d(Fz, Gz)$.

By property of functions $\psi; \phi$ and C -class, we have

$$\begin{aligned} \psi(2sb_d(Fz, Gz)) &\leq f(\psi(2sb_d(Fz, Gz)), \phi(2sb_d(Fz, Gz))) \\ &\leq \psi(2sb_d(Fz, Gz)) \\ \Rightarrow f(\psi(2sb_d(Fz, Gz)), \phi(2sb_d(Fz, Gz))) &= \psi(2sb_d(Fz, Gz)) \\ \Rightarrow \psi(2sb_d(Fz, Gz)) = 0 \text{ or } \phi(2sb_d(Fz, Gz)) &= 0 \\ \Rightarrow 2sb_d(Fz, Gz) = 0 \Rightarrow b_d(Fz, Gz) &= 0 \end{aligned} \tag{3.2.35}$$

So we obtained $b_d(Fz, Gz) = 0$, that is $Fz = Gz$. Therefore $Fz = Gz = Sz = Tz$.
 Let us prove that z is a fixed point of F .

Again we consider

$$\begin{aligned} \psi(2sb_d(Fz, z)) &\leq \psi(2s^4b_d(Fz, z)) = \psi(2s^4b_d(Fz, Gz)) \\ &\leq f(\psi(N(z, z)), \phi(N(z, z))) \\ &\leq \psi(N(z, z)) \end{aligned}$$

By property of ψ follows

$$2sb_d(Fz, z) \leq N(z, z) \tag{3.2.36}$$

where

$$\begin{aligned} N(z, z) &= \max\{b_d(Sz, Tz), b_d(Fz, Sz), b_d(Gz, Tz), b_d(Sz, Gz), b_d(Fz, Tz)\} \\ &= \max\{b_d(Fz, z), b_d(Fz, Fz), b_d(z, z), b_d(Fz, z), b_d(Fz, z)\} \\ &\leq 2sb_d(Fz, z) \end{aligned} \tag{3.2.37}$$

From (3.2.36), (3.2.37) we get

$$N(z, z) = 2sb_d(Fz, z) \tag{3.2.38}$$

In similar way as in (3.2.35) using (3.2.38), property of C -class and functions $\psi; \phi$ we obtain, $b_d(Fz, z) = 0$ and $Fz = z$. Hence z is a common fixed point.

Uniqueness. Let us prove that the fixed point is unique. If suppose that u and z are two common fixed points of F, G, S, T then from condition (b) we have,

$$\begin{aligned} \psi(2sb_d(u, z)) &\leq \psi(2s^4b_d(u, z)) = \psi(2s^4b_d(Fu, Gz)) \\ &\leq f(\psi(N(u, z)), \phi(N(u, z))) \\ &\leq \psi(N(u, z)) \end{aligned}$$

By property of ψ we get $2sb_d(u, z) \leq N(u, z)$. Also we have,

$$\begin{aligned} N(u, z) &= \max\{b_d(Su, Tz), b_d(Fu, Su), b_d(Gz, Tz), b_d(Su, Gz), b_d(Fu, Tz)\} \\ &= \max\{b_d(u, z), b_d(u, u), b_d(z, z), b_d(u, z), b_d(u, z)\} \\ &\leq 2sb_d(u, z) \end{aligned}$$

$$\text{So, } N(u, z) = 2sb_d(u, z)$$

and

$$\begin{aligned} \psi(2sb_d(u, z)) &\leq f(\psi(2sb_d(u, z)), \phi(2sb_d(u, z))) \leq \psi(2sb_d(u, z)) \\ \Rightarrow \psi(2sb_d(u, z)) &= 0 \text{ or } \phi(2sb_d(u, z)) = 0 \end{aligned}$$

As a result $b_d(u, z) = 0$ and so $u = z$.

The following is corollary of theorem 3.2 which is taken for parameter $s = 1$ in a dislocated metric space.

Corollary 3.3 Let (X, d_l) be a dislocated metric space and $S, T, F, G : X \rightarrow X$ are self-mappings such that (a) $F(X) \subset T(X)$,

$F(X) \subset T(X)$ and exists $\psi \in \Psi$, $\phi \in \Phi$ and $f \in C$ such that satisfy the condition

$$\psi(2d_l(Fx, Gy)) \leq f(\psi(N(x, y)), \phi(N(x, y))) \tag{A}$$

for all $x, y \in X$, where $N(x, y)$ is defined as in (3.1.0). If one of $F(X), S(X), T(X)$ or $G(X)$ is a complete subspace of X , then (F, S) and (G, T) have a point of coincidence in X . Moreover if suppose that (F, S) and (G, T) are weakly compatible pairs, then F, G, S, T have a unique common fixed point.

Now we give an example to support our Theorem 3.2.

Example 3.4 Let $X = [0, \infty)$ and $b_d(x, y) = (x + y)^2$. Then the pair (X, b_d) is a b -dislocated metric space with parameter $s = 2$. We define the functions F, G, S and T as follows: $Sx = \frac{2x}{5}, Tx = \frac{x}{2}, Fx = \frac{x}{30}, Gx = \frac{x}{24}$. The pairs (S, F) and (T, G) are weakly compatible, functions F, G, S and T are continuous and $F(X) \subset T(X), G(X) \subset S(X)$

We have,

$$\begin{aligned} & \psi(2s^4 b_d(Fx, Gy)) \\ &= \psi\left(32b_d\left(\frac{x}{30}, \frac{y}{24}\right)\right) = \psi\left(32\left(\frac{x}{30} + \frac{y}{24}\right)^2\right) = \psi\left(\frac{32}{36}\left(\frac{x}{5} + \frac{y}{4}\right)^2\right) \\ &= \psi\left(\frac{8(4x+5y)^2}{9 \cdot 400}\right) = \psi\left(\frac{2(4x+5y)^2}{9 \cdot 100}\right) = \psi\left(\frac{2}{9}\left(\frac{2x}{5} + \frac{y}{2}\right)^2\right) \\ &\leq \psi\left(\frac{1}{4}\left(\frac{2x}{5} + \frac{y}{2}\right)^2\right) = \psi\left(\frac{1}{4}b_d(Sx, Ty)\right) = \frac{1}{4}b_d(Sx, Ty) \leq \frac{1}{4}M(x, y) \\ &= M(x, y) - \frac{3}{4}M(x, y) = \psi(M(x, y)) - \phi(M(x, y)) \\ &= f(\psi(M(x, y)), \phi(M(x, y))) \end{aligned}$$

where $f(s, t) = s - t$; $\psi(t) = t$ and $\phi(t) = \frac{3}{4}t$, for all $x, y \in X$.

Thus all conditions of theorem 3.2 are satisfied and $x = 0$ is the unique common fixed point of S, T, F and G .

In a similar way as in Theorem 3.2, the following theorem can be proved.

Theorem 3.5 Let (X, b_d) be a complete b -dislocated metric space with parameter $s \geq 1$ and $S, T, F, G: X \rightarrow X$ are self-mappings such that (a) $F(X) \subset T(X), G(X) \subset S(X)$ and satisfy generalized $f - (\psi, \phi, s)$ weakly contractive condition. If one of $F(X), S(X), T(X)$ or $G(X)$ is closed, then (F, S) and (G, T) have a point of coincidence in X . Moreover if suppose that (F, S) and (G, T) are weakly compatible pairs, then F, G, S, T have a unique common fixed point.

For the different functions f of C -class (refer to example 2.15) we can take the following corollaries.

Corollary 3.6 Let (X, b_d) be a b_d -dislocated metric space with parameter $s \geq 1$ and $S, T, F, G : X \rightarrow X$ are self-mappings where (a) $F(X) \subset T(X), G(X) \subset S(X)$ and exists $\psi \in \Psi, \phi \in \Phi$ such that satisfies the condition

$$\psi(2s^4 b_d(Fx, Gy)) \leq \psi(N(x, y)) - \phi(N(x, y))$$

for all $x, y \in X$, where $N(x, y)$ is defined as in (3.1.0). If one of $F(X), S(X), T(X)$ or $G(X)$ is a complete subspace of X , then (F, S) and (G, T) have a point of coincidence in X . Moreover if suppose that (F, S) and (G, T) are weakly compatible pairs, then F, G, S, T have a unique common fixed point.

Proof. If we take in Theorem 3.2 the function f as $f(s, t) = s - t$ then we get the corollary.

Corollary 3.7 Let (X, b_d) be a b_d -dislocated metric space with parameter $s \geq 1$ and $S, T, F, G : X \rightarrow X$ are self-mappings where (a) $F(X) \subset T(X), G(X) \subset S(X)$ and exists $\psi \in \Psi, \phi \in \Phi$ such that satisfies the condition

$$\psi(2s^4 b_d(Fx, Gy)) \leq \frac{\psi(N(x, y)) - \phi(N(x, y))}{1 + \phi(N(x, y))}$$

for all $x, y \in X$, where $N(x, y)$ is defined as in (3.1.0). If one of $F(X), S(X), T(X)$ or $G(X)$ is a complete subspace of X , then (F, S) and (G, T) have a point of coincidence in X . Moreover if suppose that (F, S) and (G, T) are weakly compatible pairs, then F, G, S, T have a unique common fixed point.

Proof. This corollary is obtained from Theorem 3.2 if we take as f the function $f(s, t) = \frac{s-t}{1+t}$.

Corollary 3.8 Let (X, b_d) be a b_d -dislocated metric space with parameter $s \geq 1$ and $S, T, F, G : X \rightarrow X$ are self-mappings where (a) $F(X) \subset T(X), G(X) \subset S(X)$ and exists $\psi \in \Psi, \phi \in \Phi$ such that satisfies the condition

$$\psi(2s^4 b_d(Fx, Gy)) \leq \frac{\psi(N(x, y))}{1 + \phi(N(x, y))}$$

for all $x, y \in X$, where $N(x, y)$ is defined as in (3.1.0). If one of $F(X), S(X), T(X)$ or $G(X)$ is a complete subspace of X , then (F, S) and (G, T) have a point of coincidence in X . Moreover if suppose that (F, S) and (G, T) are weakly compatible pairs, then F, G, S, T have a unique common fixed point.

Proof. If we take in Theorem 3.2 the function f as $f(s, t) = \frac{s}{1+t}$ then we get the corollary.

Corollary 3.9 Let (X, b_d) be a b_d -dislocated metric space with parameter

$s \geq 1$ and $S, T, F, G : X \rightarrow X$ are self-mappings where (a) $F(X) \subset T(X), G(X) \subset S(X)$ and exists $\psi \in \Psi, \phi \in \Phi$ such that satisfies the condition

$$\psi(2s^4 b_d(Fx, Gy)) \leq \frac{\psi(N(x, y))\phi(N(x, y))}{1 + \phi(N(x, y))}$$

for all $x, y \in X$, where $N(x, y)$ is defined as in (3.1.0). If one of $F(X), S(X), T(X)$ or $G(X)$ is a complete subspace of X , then (F, S) and (G, T) have a point of coincidence in X . Moreover if suppose that (F, S) and (G, T) are weakly compatible pairs, then F, G, S, T have a unique common fixed point.

Proof. If we take in Theorem 3.2 the function f as $f(s, t) = \frac{st}{1+t}$ then we get the corollary.

Remark 3.10 As a consequence of theorem 3.2 and all corollaries for taking

- 1) the parameter $s = 1$.
- 2) the parameter $s = 1$ and $G = F$ and $T = S$.
- 3) functions f from the set C and taking $\psi(t) = t$ and $\phi(t) = (1 - k)t$.

We can establish many other corollaries in the setting of dislocated and b -dislocated metric spaces.

- 4) Our results unify, generalize, and extend several ones obtained earlier in a lot of papers concerning b -metric, dislocated and b -dislocated metric spaces (as in references [13] [15] [25] [26] [30] [31]).

In this section, we use the notion of T -contractions introduced by Beiranvad et al. in [3] as a new class of contractive mappings, by generalizing the contractive condition in terms of another function. These contractions have been used by many authors. In this direction in order to generalize some other well-known results as in [32] [33] [34] we extend the notion of $f - (\psi, \phi, s)$ generalized weak contractions in the context of T -contractions, giving the following theorem.

Theorem 3.11 Let (X, b_d) be a complete b -dislocated metric space with parameter $s \geq 1$ and $T : X \rightarrow X$ be an injective, continuous and sequentially convergent mapping. Let $F, G : X \rightarrow X$ be self-mappings and if exist $\psi \in \Psi, \phi \in \Phi$ and $f \in C$ such that

$$\psi(2s^4 b_d(TFx, TGy)) \leq f(\psi(N(Tx, Ty)), \phi(N(Tx, Ty))) \tag{B}$$

for all $x, y \in X$, where

$$N(Tx, Ty) = \max \left\{ b_d(Tx, Ty), b_d(Tx, TFx), b_d(Ty, TGy), \frac{b_d(Tx, TGy) + b_d(Ty, TFx)}{4s} \right\}$$

then F, G have a unique common fixed point.

Proof. We divide the proof into two parts as follows.

First part. Each fixed point u of F is a fixed point of G and conversely, and the

common fixed point of F, G is unique.

Let $u \in X$ be a fixed point of F . If $b_d(Fu, Gu) = 0$ then, follows that $u = Fu = Gu$ and so u is a fixed point of G . If we suppose that $b_d(Fu, Gu) > 0$, we evaluate $N(Tu, Tu)$ as;

$$\begin{aligned} N(Tu, Tu) &= \max \left\{ b_d(Tu, Tu), b_d(Tu, TFu), b_d(Tu, TGu), \frac{b_d(Tu, TGu) + b_d(Tu, TFu)}{2s} \right\} \\ &= \max \left\{ b_d(Tu, Tu), b_d(Tu, Tu), b_d(Tu, TGu), \frac{b_d(Tu, TGu) + b_d(Tu, Tu)}{4s} \right\} \\ &\leq 2sb_d(Tu, TGu) \end{aligned}$$

So we have

$$N(Tu, Tu) \leq 2sb_d(Tu, TGu) \tag{3.11.1}$$

Then by contractive condition (B), we have

$$\begin{aligned} \psi(2sb_d(Tu, TGu)) &\leq \psi(2s^2b_d(TFu, TGu)) \\ &\leq f(\psi(N(Tu, Tu)), \phi(N(Tu, Tu))) \\ &\leq \psi(N(Tu, Tu)) \end{aligned}$$

By property of ψ we have

$$2sb_d(Tu, TGu) \leq N(Tu, Tu) \tag{3.11.2}$$

Hence from (3.11.1) and (3.11.2) follows $N(Tu, Tu) = 2sb_d(Tu, TGu)$.

Again

$$\begin{aligned} \psi(2sb_d(Tu, TGu)) &\leq \psi(2s^2b_d(TFu, TGu)) \\ &\leq f(\psi(N(Tu, Tu)), \phi(N(Tu, Tu))) \\ &= f(\psi(2sb_d(Tu, TGu)), \phi(2sb_d(Tu, TGu))) \\ &\leq \psi(2sb_d(Tu, TGu)) \\ \Rightarrow f(\psi(2sb_d(Tu, TGu)), \phi(2sb_d(Tu, TGu))) &= \psi(2sb_d(Tu, TGu)) \\ \Rightarrow \psi(2sb_d(Tu, TGu)) = 0 \text{ or } \phi(2sb_d(Tu, TGu)) = 0 \end{aligned}$$

By property of ψ, ϕ we get $b_d(Tu, TGu) = 0$ that is $Tu = TGu$ and by injectivity of T follows $u = Gu$.

Thus u is a fixed point of G . Similarly we can prove the other implication.

Second part. We prove that the function F has a fixed point. We define two iterative sequences $\{x_n\}$ as $x_{2n+1} = fx_{2n}$ and $x_{2n+2} = gx_{2n+1}$, and $\{y_n\}$ as $y_n = Tx_n$ for each $n = 0, 1, 2, \dots$.

If for some n , we have $x_{2n+1} = x_{2n}$ then $x_{2n} = x_{2n+1} = fx_{2n}$ and x_{2n} is a fixed point of F and by the first part x_{2n} is a fixed point of G and the proof is completed.

Now, we assume that $x_{2n+1} \neq x_{2n}$ for all n , and since T is injective we have $Tx_{2n+1} \neq Tx_{2n}$; then from condition (B) of theorem, we have

$$\begin{aligned} \psi(2sb_d(Tx_{2n+1}, Tx_{2n})) &\leq \psi(2s^2b_d(Tx_{2n+1}, Tx_{2n})) = \psi(2sb_d(Tfx_{2n}, Tgx_{2n-1})) \\ &\leq f(\psi(N(Tx_{2n}, Tx_{2n-1})), \phi(N(Tx_{2n}, Tx_{2n-1}))) \\ &\leq \psi(N(Tx_{2n}, Tx_{2n-1})) \end{aligned}$$

where

$$\begin{aligned} &N(Tx_{2n}, Tx_{2n-1}) \\ &= \max \left\{ b_d(Tx_{2n}, Tx_{2n-1}), b_d(Tx_{2n}, Tfx_{2n}), b_d(Tx_{2n-1}, Tgx_{2n-1}), \right. \\ &\quad \left. \frac{b_d(Tx_{2n}, Tgx_{2n-1}) + b_d(Tx_{2n-1}, Tfx_{2n})}{4s} \right\} \\ &= \max \left\{ b_d(Tx_{2n}, Tx_{2n-1}), b_d(Tx_{2n}, Tx_{2n+1}), b_d(Tx_{2n-1}, Tx_{2n}), \right. \\ &\quad \left. \frac{b_d(Tx_{2n}, Tx_{2n}) + b_d(Tx_{2n-1}, Tx_{2n+1})}{4s} \right\} \\ &\leq \max \left\{ b_d(Tx_{2n}, Tx_{2n-1}), b_d(Tx_{2n}, Tx_{2n+1}), b_d(Tx_{2n-1}, Tx_{2n}), \right. \\ &\quad \left. \frac{2sb_d(Tx_{2n}, Tx_{2n-1}) + s[b_d(Tx_{2n-1}, Tx_{2n}) + b_d(Tx_{2n}, Tx_{2n+1})]}{4s} \right\} \end{aligned} \tag{3.11.3}$$

If $b_d(Tx_{2n}, Tx_{2n-1}) < b_d(Tx_{2n+1}, Tx_{2n})$ then from (3.11.3) we get

$$N(Tx_{2n}, Tx_{2n-1}) \leq b_d(Tx_{2n+1}, Tx_{2n}) \tag{3.11.4}$$

Using condition (B) and property of C-class, we have

$$\begin{aligned} \psi(b_d(Tx_{2n+1}, Tx_{2n})) &\leq \psi(2s^2b_d(Tx_{2n+1}, Tx_{2n})) \\ &= \psi(2s^2b_d(Tfx_{2n}, Tgx_{2n-1})) \\ &\leq f(\psi(N(Tx_{2n}, Tx_{2n-1})), \phi(N(Tx_{2n}, Tx_{2n-1}))) \\ &\leq \psi(N(Tx_{2n}, Tx_{2n-1})) \end{aligned}$$

By property of function ψ we have

$$b_d(Tx_{2n+1}, Tx_{2n}) \leq N(Tx_{2n}, Tx_{2n-1}) \tag{3.11.5}$$

From (3.11.4) and (3.11.5) we get

$$N(Tx_{2n}, Tx_{2n-1}) = b_d(Tx_{2n+1}, Tx_{2n}) \tag{3.11.6}$$

Also from condition of theorem and (3.11.6), we have

$$\begin{aligned} \psi(b_d(Tx_{2n+1}, Tx_{2n})) &\leq \psi(2s^2b_d(Tx_{2n+1}, Tx_{2n})) \\ &= \psi(2s^2b_d(Tfx_{2n}, Tgx_{2n-1})) \\ &\leq f(\psi(N(Tx_{2n}, Tx_{2n-1})), \phi(N(Tx_{2n}, Tx_{2n-1}))) \\ &= f(\psi(b_d(Tx_{2n+1}, Tx_{2n})), \phi(b_d(Tx_{2n+1}, Tx_{2n}))) \\ &\leq \psi(b_d(Tx_{2n+1}, Tx_{2n})) \end{aligned}$$

Also we have,

$$\begin{aligned} \psi(b_d(Tx_{2n+1}, Tx_{2n})) &\leq f(\psi(b_d(Tx_{2n+1}, Tx_{2n})), \phi(b_d(Tx_{2n+1}, Tx_{2n}))) \\ &\leq \psi(b_d(Tx_{2n+1}, Tx_{2n})) \\ \Rightarrow f(\psi(b_d(Tx_{2n+1}, Tx_{2n})), \phi(b_d(Tx_{2n+1}, Tx_{2n}))) &= \psi(b_d(Tx_{2n+1}, Tx_{2n})) \\ \Rightarrow \psi(b_d(Tx_{2n+1}, Tx_{2n})) = 0 \text{ or } \phi(b_d(Tx_{2n+1}, Tx_{2n})) &= 0 \end{aligned}$$

By property of ψ and ϕ we have $b_d(Tx_{2n+1}, Tx_{2n}) = 0$ so $Tx_{2n+1} = Tx_{2n}$ which is a contradiction since we supposed $Tx_{2n+1} \neq Tx_{2n}$.

Hence, we have

$$b_d(Tx_{2n+1}, Tx_{2n}) \leq b_d(Tx_{2n}, Tx_{2n-1}).$$

Similarly, we have that

$$b_d(Tx_{2n+2}, Tx_{2n+1}) \leq b_d(Tx_{2n+1}, Tx_{2n})$$

Therefore for all n we have

$$b_d(Tx_{n+1}, Tx_n) \leq b_d(Tx_n, Tx_{n-1})$$

and $\{b_d(Tx_{n+1}, Tx_n)\}$ is a non increasing sequence of nonnegative real numbers and bounded below. Hence there exists $r \geq 0$ such that

$$\lim_{n \rightarrow \infty} b_d(y_{n+1}, y_n) = \lim_{n \rightarrow \infty} N(Tx_{n+1}, Tx_n) = r$$

By the property of functions ψ and ϕ , we have

$$\psi(r) = \lim_{n \rightarrow \infty} \psi(N(Tx_{n+1}, Tx_n)) \text{ and } \phi(r) \leq \liminf_{n \rightarrow \infty} \phi(N(Tx_{n+1}, Tx_n)) \quad (3.11.7)$$

If we consider condition (B) we have,

$$\begin{aligned} \psi(b_d(Tx_{n+1}, Tx_n)) &\leq \psi(2s^2 b_d(Tx_{n+1}, Tx_n)) \\ &\leq f(\psi(N(Tx_n, Tx_{n-1})), \phi(N(Tx_n, Tx_{n-1}))) \quad (3.11.8) \\ &\leq \psi(N(Tx_n, Tx_{n-1})) \end{aligned}$$

Taking the upper limit as $n \rightarrow \infty$ in (3.11.8) and using (3.11.7) we have that,

$$\begin{aligned} \psi(r) &\leq f(\psi(r), \phi(r)) \leq \psi(r) \Rightarrow f(\psi(r), \phi(r)) = \psi(r) \\ \Rightarrow \psi(r) &= 0 \text{ or } \phi(r) = 0. \end{aligned} \quad (3.11.9)$$

From (3.11.9) and property of ψ and ϕ follows that $r = 0$ and also

$$\lim_{n \rightarrow \infty} b_d(y_{n+1}, y_n) = \lim_{n \rightarrow \infty} N(Tx_{n+1}, Tx_n) = 0 \quad (3.11.10)$$

In a similar way as in Theorem 3.2 we can show that the sequence $\{Tx_n\}$ (also $\{y_n\}$) is a b_d -Cauchy sequence in b -dislocated metric space (X, b_d) . Since X is complete there exists $z \in X$ such that $\lim_{n \rightarrow \infty} y_n = \lim_{n \rightarrow \infty} Tx_n = z$. Since T is sequentially convergent, we can deduce that $\{x_n\}$ is convergent to $u \in X$ and the subsequences $\{Fx_{2n}\}, \{Gx_{2n+1}\}$ converge to u , that means

$$\lim_{n \rightarrow \infty} b_d(y_{2n}, u) = 0 \text{ and } \lim_{n \rightarrow \infty} b_d(y_{2n+1}, u) = 0.$$

Since T is continuous we have $Tu = \lim_{n \rightarrow \infty} Tx_n = \lim_{n \rightarrow \infty} y_n = z$.

Let we prove that u is a fixed point of F and G ($Fu = Gu = u$). If suppose that $u \neq Fu$ then since T is injective follows $z = Tu \neq TFu$ (and $b_d(Tu, TFu) > 0$)

Consider,

$$\begin{aligned}
 N(Tu, Tx_{2n-1}) &= \max \left\{ b_d(Tu, Tx_{2n-1}), b_d(Tu, Tfu), b_d(Tx_{2n-1}, Tgx_{2n-1}), \right. \\
 &\quad \left. \frac{b_d(Tu, Tgx_{2n-1}) + b_d(Tx_{2n-1}, Tfu)}{4s} \right\} \\
 &= \max \left\{ b_d(Tu, y_{2n-1}), b_d(Tu, Tfu), b_d(y_{2n-1}, y_{2n}), \right. \\
 &\quad \left. \frac{b_d(Tu, y_{2n}) + b_d(y_{2n-1}, Tfu)}{4s} \right\} \tag{3.11.11}
 \end{aligned}$$

Taking the upper limit in (3.11.11) and using lemma (2.13), and result (3.11.10) we get

$$\limsup_{n \rightarrow \infty} N(Tu, Tx_{2n-1}) \leq \max \left\{ 0, b_d(Tu, Tfu), 0, \frac{sb_d(Tu, Tfu)}{4s} \right\} = b_d(Tu, Tfu) \tag{3.11.12}$$

According to contractive condition (B) we have,

$$\begin{aligned}
 \psi(2s^2 b_d(TFu, Tx_{2n})) &= \psi(2s^2 b_d(TFu, Tgx_{2n-1})) \\
 &\leq f(\psi(N(Tu, Tx_{2n-1})), \phi(N(Tu, Tx_{2n-1}))) \\
 &\leq \psi(N(Tu, Tx_{2n-1}))
 \end{aligned} \tag{3.11.13}$$

Taking the upper limit in (3.11.13) and using lemma (2.13), we obtain,

$$\psi(2sb_d(TFu, Tu)) = \psi\left(2s^2 \frac{1}{s} b_d(TFu, Tu)\right) \leq \psi(sb_d(TFu, Tu))$$

This implies that $b_d(Tu, Tfu) = 0$ that is $Tu = Tfu$ which is a contradiction. As a result $u = Fu$ and u is a fixed point of F . By the first part of proof u is a fixed point of G and also a common fixed point.

Easily using the contractive condition (B) of theorem can be proved that the common fixed point is unique.

Example 3.12 Let $X = [0, \infty)$ be equipped with the b -dislocated metric $b_d(x, y) = (x + y)^2$ for all $x, y \in X$, where $s = 2$. It is clear that (X, b_d) is a complete b -dislocated metric space. Also let be the self-mappings $T, F, G: X \rightarrow X$ defined by $T(x) = \frac{x}{2}, F(x) = \frac{x}{5}, G(x) = \frac{x}{10}$. We note, T is continuous and sequentially convergent.

If $\psi(t) = t, \phi(t) = \frac{17}{25}t$ and $f(s, t) = s - t$ then for each $x, y \in X$, we have

$$\begin{aligned}
 \psi(2s^2 b_d(TFx, TGy)) &= 2s^2 b_d(TFx, TGy) = 8b_d\left(\frac{x}{10}, \frac{y}{20}\right) = 8\left(\frac{x}{10} + \frac{y}{20}\right)^2 \leq 8\left(\frac{x}{10} + \frac{y}{10}\right)^2 \\
 &= \frac{8}{25} \frac{(x+y)^2}{4} = \frac{8}{25} \left(\frac{x}{2} + \frac{y}{2}\right)^2 = \frac{8}{25} b_d(Tx, Ty) \leq \frac{8}{25} N(Tx, Ty) \\
 &= N(Tx, Ty) - \frac{17}{25} N(Tx, Ty) = \psi(N(Tx, Ty)) - \phi(N(Tx, Ty)) \\
 &= f(\psi(N(Tx, Ty)), \phi(N(Tx, Ty)))
 \end{aligned}$$

Thus T, F, G satisfy all the conditions of Theorem 3.11. Moreover $x = 0$ is the unique common fixed point of F, G .

If in theorem 3.11 we take $F = G$ we get the following corollary.

Corollary 3.13 Let (X, b_d) be a complete b -dislocated metric space with parameter $s \geq 1$ and $T, G : X \rightarrow X$ be two self mappings, where T is injective, continuous and sequentially convergent. If exist $\psi \in \Psi$, $\phi \in \Phi$ and $f \in C$ such that

$$\psi(2s^2 b_d(TGx, TGy)) \leq f(\psi(N(Tx, Ty)), \phi(N(Tx, Ty)))$$

for all $x, y \in X$, where

$$N(Tx, Ty) = \max \left\{ b_d(Tx, Ty), b_d(Tx, TGx), b_d(Ty, TGy), \frac{b_d(Tx, TGy) + b_d(Ty, TGx)}{4s} \right\}$$

then G has a unique fixed point.

Corollary 3.14 Let (X, b_d) be a complete b -dislocated metric space with parameter $s \geq 1$ and $T : X \rightarrow X$ be an injective, continuous and sequentially convergent mapping. Let $F, G : X \rightarrow X$ be self-mappings and if exist $\psi \in \Psi$, $\phi \in \Phi$ such that

$$\psi(2s^4 b_d(TFx, TGy)) \leq \psi(N(Tx, Ty)) - \phi(N(Tx, Ty))$$

for all $x, y \in X$, where

$$N(Tx, Ty) = \max \left\{ b_d(Tx, Ty), b_d(Tx, TFx), b_d(Ty, TGy), \frac{b_d(Tx, TGy) + b_d(Ty, TFx)}{4s} \right\}$$

then F, G have a unique common fixed point.

Proof. If we take in Theorem 3.11 the function $f \in C$ as $f(s, t) = s - t$ then we get the corollary.

Remark 3.15

- 1) Theorem 3.11 generalizes, extends and unifies results as Theorem 8 in [32], Theorem 4 in [33] and many existing results of literature in a set effective larger as b -dislocated metric spaces.
- 2) The class C of functions has a general character and so according to example 2.15, we can provide many results from theorem 3.11.
- 3) If we take in theorem 3.11 the parameter $s = 1$ as a consequence, we obtain results in a dislocated metric space.
